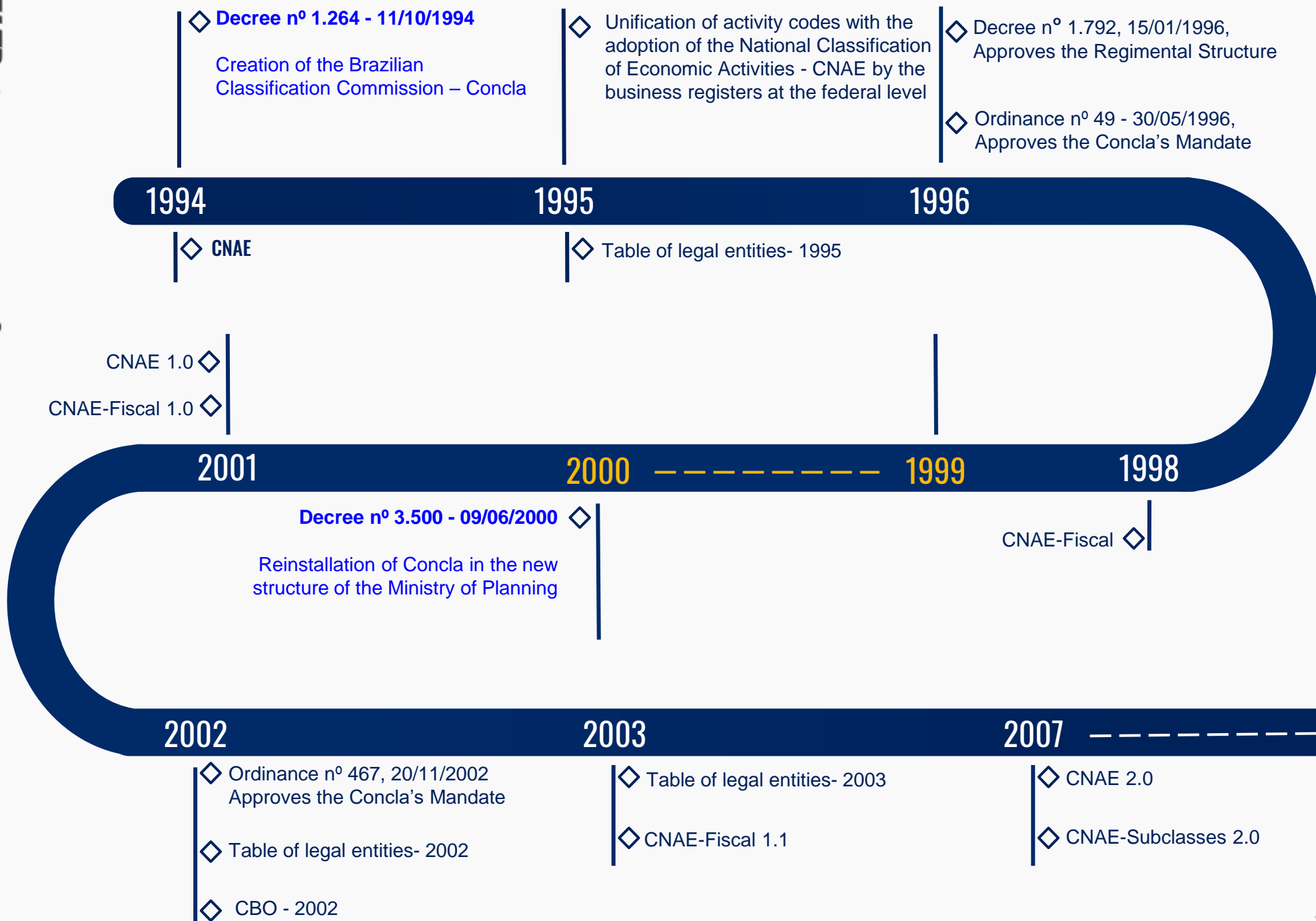

- ✓ Better reflect changes in the structure and composition of the economy;
- ✓ Improved attribution of the CNAE code and;
- ✓ Development of new instruments.



Challenges

- ✓ Significant costs of reworking databases, introducing changes in Public Administration records and reviewing historical series;
- ✓ Synchronization in the adoption of CNAE 3.0;
- ✓ Deficit of technicians trained in classification;
- ✓ Re-creation of a Technical Subcommittee for non-statistical purposes;
