What is GSIM?

- The Generic Statistical Information Model (GSIM) is the first internationally endorsed reference framework for statistical information. It provides a set of standardised, consistently described information objects, which can be used as inputs and outputs in the design and the production of statistics.
- A significant benefit of using GSIM is that it provides a **common language to improve communication at different levels**:
 - Between the different roles in statistical business process (business and information technology experts);
 - Between the different statistical subject matter domains;
 - Between statistical organisations at national and international levels.
- GSIM provides the foundation for in-depth collaboration, standardisation, or, sharing of tools and methods.
- GSIM is related to the Generic Statistical Business Process Model (GSBPM). GSIM objects can be used for inputs and outputs of each GSBPM sub-processes.
- Statistics Canada has officially adopted GSIM as a model, same as GSBPM.

Documenting changes in classification versions using GSIM

- GSIM contains objects which specify information about the real world "information objects", around 130 of them (e.g., data and metadata such as statistical classifications as well as the rules and parameter inputs needed for production processes to run for example, data editing rules).
- This presentation only concentrates on a tiny part of GSIM, which is related to '<u>Statistical Classification Model</u>', an defines the key concepts that are relevant to structuring statistical classification metadata, and provides the conceptual framework for the development of a statistical classification management system. It is aimed at classification experts.
- The Statistical Classification Model contains definitions of object types such as: Classification family, Classification series, Statistical Classification, Level, Correspondence table, Classification index and index entry, Classification item, etc.
- The Statistical Classification Model also contains a specific section on <u>A Typology of</u> <u>Classification Item changes</u>. This is what we are using here with concrete examples to document changes between ISIC Rev 4 and ISIC Rev 5.



Types of changes in the classification, including Codes, Titles and Classification Items (Based on GSIM)

VC - VIRTUAL CHANGE	Virtual change stands for changes in coding and/or naming, while the meaning of the classification item remains the same. Code change and name change do not result in border/scope changes of the classification item.
RC - REAL CHANGE	Real change stands for changes in meaning, whether or not accompanied by changes in naming (title or definition) and/or coding.
NC- NOTIFICATION CHANGE	A classification item stays the same while changes are made at lower levels without change in scope. – This is not in GSIM (Adaptation at Statistics Canada)

Applying GSIM Typology For ISIC Rev 4 to ISIC Rev 5

- Used to identify the type of changes from ISIC Rev 4 to ISIC Rev 5
- Enabled the production of a clear and (machine) readable correspondence table
- Helps produce consistent and repeatable explanatory notes
- Could be implemented in a machine readable format or embedded in a classification management software (e.g., Aria used by Statistics Canada)



VC - Virtual Change in ISIC Rev 5 (examples)

VC1 - CODE CHANGE

- A classification item expires, while its denotation(content) proceeds as the denotation(content) of an emerging(new) classification item.
 - In fact, for a code change to be part of virtual change, the code of a classification item changes, while its denotation (content including its borders and scope) remains the same.

VC2 - NAME CHANGE

- The name (title or definition) of a classification item changes, while its denotation (content including its borders and scope) remains the same.
 - Note that not all changes in (the wording of) definitions imply changes in meaning. Indeed, changes which "merely" intend to enhance the clarity or quality of a title and/or definition, or to further operationalise a definition on the basis of situations encountered in practice, do not affect the meaning of a classification item.

"Denotation" = primary meaning/content of a classification item

Remember: For a code change to be part of virtual change, the code of a classification item changes, while its denotation (content including its borders and scope) remains the same.

In these scenarios the code was changed (VC1); and the title or explanatory notes were also modified, hence the VC2 type change. Of course, no change in scope.



RC - Real Change in ISIC Rev 5 (examples)

"Denotation" = primary meaning/content of a classification item

Real change stands for changes in meaning, whether or not accompanied by changes in naming (title or definition) and/or coding.

RC1 - DELETION	A classification item expires, while its denotation(content) reduces to zero; it does not proceed as (part of the) denotation(content) of one or more other (existing) classification item(s).
RC2 - CREATION	The mirror image of deletion: a classification item emerges, while its denotation(content) is not (part of) the denotation(content) of one or more existing classification items.

We did not have any instances of RC1 in the ISIC Rev 4 to ISIC Rev 5 correspondence table. One case was flagged as RC2: **class 6039** - Social network sites and other content distribution activities; this because it would have been very difficult to link it to a specific class back to ISIC Rev 4, although the classification is considered exhaustive.

Those two cases should be rare for an established classification such as ISIC or even for any well developed classification because of the principal of 'exhaustiveness'.





RC - Real Change in ISIC Rev 5 (examples)

Real change stands for changes in meaning, whether or not accompanied by changes in naming (title or definition) and/or coding.
