- ▶ The changes to Section J from ISIC Rev 4 resulted in what was Section K: Financial and insurance activities becoming Section L: Financial and insurance activities
- ▶ The main changes were:

# Main Changes

- ▶ The new Section J retained Divisions 56, 59 and 60 of ISIC Rev 4 and news agencies and post-production conversion services to streaming formats (Division 63)
- ▶ The new Section K now holds the old Divisions 61, 62 and the remainder of Division 63 which was not kept above
