Type of questions used in Caribbean region

- Generic question on presence of long-standing (difficulty/problem) illness, disability or infirmity that limits carrying out data-to-day activities followed by WG questions: Guyana, Montserrat, Trinidad and Tobago
- Screener about whether household members have disabilities followed by list of impairments and WG question – Anguilla, Aruba, Cayman Is**, Curacao, Sin Marteen
- Screener about whether household members have disabilities followed by list of impairments and medical conditions – Bahamas, Barbados, Bermuda

Aruba	Because of a physical, mental of emotional health condition, do you have difficulty communicating?
Belize	(1) added domain of "other"; (2) separate categories for learning and behavioural disorders;(3)response category: dk/ns
British Virgin Is	(1) Hearing does not include use of hearing aid; (2) [a]Behaviorial-mental retardation, [b] Learning or understanding
Curacao	(1) asked if respondent has problems instead of difficulty; (2) communicating due to a physical, mental or emotional problem
Grenada	Respond only if you have a permanent or where the disability has been continuous for six months or more
