Current Situation

The geographic location occupied by Jordan made it a gateway to many population movements, whether in times of peace or conflict since ancient times.

Jordan has been traditionally receiving and sending a migrant. Gaining almost more than three and half million people during the second half of the previous century, and losing less than a million.

Inflow of labor migrants from the neighboring countries – mainly from Egypt- to Jordan has grown since the mid-1970s and accelerated during the 1980s and 1990s. Iraqis came in the large numbers after the Second Gulf War in 1991, and many of them used Jordan as a passage to reach other countries of destination. The Gulf Crisis caused the return of about 300 thousand of Jordanians from the Arab Gulf states.


Current Situation

As a result of the Syrian crises, Jordan received more than 1,3 million migrants

All these migratory movements had impact on different aspects of the country, mainly on the economy, labor market, infrastructure, social structure and other aspects.

Importance of Migration Statistics

The importance of migration data to decision makers, planners, international organizations and other users is to identify its size, levels and trends in Jordan. The aim is to contribute to making the right decisions and necessary measures to tackle and organize this phenomenon. The country can also direct investment projects, services and infrastructure to the right direction.

Jordan International Migration Survey 2014

- The Department of Statistics conducted a specialized survey of the International Migration Survey on 2014
- The number of survey questionnaires was six and a booklet was prepared for each questionnaires.
- The questionnaires and the sample were as follows :

Sample

- In order to design the sample of this survey,
- Data of the General Population and Housing Census 2004.
- Two questions were added in the survey of 40 jobs created in 2012:Sample survey of 40 Thousand families families
- Does the family have individuals living outside Jordan?
- Or were they living outside Jordan and returning to it and living in Jordan now?
- Only 686 families had individuals

Sample

- The cluster stratified method was used
- Multi-stage is the method used in the design of the international migration survey sample.
- For the purposes of this survey, the society was divided into three strata of each class consisting of a number of districts based on the proportion of immigrants in these districts:

Models of Questionnaires

- 1: the household questionnaires
- 2: Immigrant Return questionnaires
- 3: Current Immigrant
- 4: The non-immigrant resident questionnaires
- 5: questionnaires of forced migrants
- 6: Housing Conditions

 A meeting was held in the DoS with the Director General and Director of the Directorate of Data of Arrivals and Departures in the GID. It was agreed in principle on the electronic link between the two departments and work under the study to assess the need of servers and computers supported by UNSD

Required Assistance

Jordan expects to receive support from the UNSD in particular in the following fields:

- 1) Electronic link between the institutions concerned with migration through adoption of new technologies and modern equipment.
- 2) Setting up of the infrastructure for data preparation.
- 3) Building a platform for data.
- 4) Transfer of international expertise.
- 5) Study the experience of developed countries in migration management.

Recommendations

- The flow of migration data is based on the Department of Statistics and in coordination with all government agencies in the Kingdom.
- The Department of Statistics is the official authority to provide data on migration
- Raise the capacity of the staff in the Department and other bodies to calculate all indicators related to migration, and the subject of the development of sustainable development through workshops and specialized training for this purpose, and access to new methodologies.
- Work towards an electronic link between all national institutions dealing with migration data as well as data exchange between them.
 - Coordination between various international and national agencies and institutions to standardize common methodologies, definitions.
 - Provide financial support for analysis of migration data.
