International migration central to achieving inclusive social and economic sustainable development New attention on migration data Call for high-quality data on: Stocks Flows



- lack of harmonization, compilation and dissemination of statistics
- lack of coordination and integration of statistics from ≠ sources
- lack of systematic analysis and research on determinants and impact of migration
- lack of methods
- lack of capacity to produce, analyse, communicate and use migration data

#### An initial assessment of national needs for capacity-building

- Population censuses better data analysis and dissemination
- Surveys sampling, standardized question modules on various topics, data analysis and dissemination
- Administrative data having access to admin data; how to use them for statistical purposes; how to link data sources to establish an integrated system
- Non-traditional data sources how to work with big data; need for training on new technologies
- National migration data strategy how to strengthen the legal framework for better collaboration and data flows within the country
- Data communication and use: Using migration data to inform policies; how to disseminate and communicate data to the public and policymakers?


- Mechanism for better coordination among global/regional entities
