Ensure access to basic services by migrants and temporary populations vis-à-vis other population groups

- Develop special programs for migrants and temporary populations to access basic services
 - ✓ The Ghana Immigration Service distributes study visas for university students
 - ✓ Foreign student quota by universities
 - ✓ Data on foreign students by disaggregation
- What is the proportion of migrants covered under health insurance schemes?
- All migrants and their families have access to social security for old age, invalidity, and survivors
- Data on labour force, disability status, refugees – captured in the Ghana 2021 Population and Housing Census – with disaggregation
- Migrant and temporary population living in households with access to electricity, improved drinking water, basic drinking water services

Increase the integration and wellbeing of migrants

- The Ghana 2021 Population and Housing Census – data on disaggregating migrants and temporary population by age, sex, foreign-born / native-born status, and citizenship status
 - ✓ To identify those migrants that may live in deprived situations using non-monitory indicators captured in Ghana PHC
 - ✓ Providing data on the migrant population that may require assistance to better integrate into society.
 - ✓ Identification of migrant population key but sometimes difficult to practice

Increase the integration and wellbeing of migrants

- 2021 Ghana Population and Housing Census provides data on:
 - Literacy status and school attendance - disaggregated by
 - ✓ age
 - ✓ Sex
 - ✓ foreign-born / native-born status
 - ✓ citizenship status

Indicators to compare migrants with others population groups.

Empower labour migrants

- Data on labour force participation – proportion of migrants in employment, unemployed and those outside the labour force
- Providing data on informalities – vulnerability in terms of labour
- Proportion of women in managerial positions – censuses, surveys and administrative data
- The websites of the Ministry of the Interior, Ghana Refugee Board and related agencies are clear and contribute to providing the information required to empower labour migrants

Eliminate all forms of discrimination and ending violence against migrants and temporary populations

- The role of institutions such as the CHRAJ and the Ghana Police Service in mediating the impact of migration on discrimination
- Documentation of such mediation (data)
- Data on the proportion of migrant population subjected to the following in the previous 12 months - Ministry of Gender
 - ✓ physical violence
 - ✓ psychological violence
 - ✓ sexual violence
