# Some questions to promote discussion

Do you agree with the 9 TTs defined? Do we need more TTs?
Should we combine some of the 9 TTs?

Maybe some concentration is recomended.

 Are these 9 TTs sufficient to revise all relevant parts of the P&R?

It is sufficient.

Maybe some concentration is recommended considering the amount of people involved

- TT2 is not explicitly listed in P&R. Do we need to cover it?

It is an important issue. But do we need an specific TT? It could be combined with TT3. TT4 could also be very specific...

 Are there other important topics for 2030 round censuses that the 9 TTs have not covered or need more relevance?

Not new TTs.

# Some questions to promote discussion

 Do the scope of work for each TT outlined in the concept note cover sufficient ground?

Yes, they cover enough ground. In some cases it could be difficult to deal with all the details

#### Suggestions:

- What about including in some cases box case studies with success cases from some specific countries?
- New topics: multirresidence, information about recycling, energy saving methods, availability of services around the dwelling...
