The above registration percentages refer to deaths occurring in 2020 which have been registered by the civil registration system within 1 year of occurrence. It should be noted that some death cases (particularly those aged 0-64) may have significant time lag (longer than 1 year) between occurrence and registration, such as unnatural death cases requiring a verdict by the Coroner's Court. Nevertheless, all deaths in Hong Kong would ultimately get registered, which is mandated by the law.
