OBSTACLES

Civil Registration

- ➤ The existing legislature needs to be repealed and replaced by a proper legal framework to facilitate meaningful vital statistics
- ➤ Outreach. District registrars currently in hospitals and urban communities. Added to the legal timeline of 3 months gives rise to lags and possible opportunities for under coverage, (1 main office, 3 sub offices, 15 e-registration centers.)

Vital Statistics

- > Late submission of data from RG
- Inaccurate or incomplete datasets from the RG
- Queries need to be resolved
- > Harmonization of codes, concepts and definitions
- > Re-establish automated system for coding
- Lack of staff. Retention also an issue
- Migration data
- > Training of all stakeholders

ASSESSING QUALITY

- From Aug 2014, all registered deaths have been linked via a PIN number on the birth certificate.
- Introduce consistency and validation checks at the RG when data are being captured
- Comparison of births with census data from 2011 PHC
- CARPHA does validation checks on age, sex. cause of death. Trinidad & Tobago's ill defined deaths within PAHO's acceptable range, about 1.9%
- UNICEF/MOH under 5 Mortality Study done in 2013 to measure child health outcomes.

STRATEGIES

- Development of the NSDS(National Strategy for the Development of Statistics)
- MOU to be signed between RG and CSO
- Establishment of an inter-ministerial committee from MoH, CSO, RG, Judiciary, other civil society organizations to build capacity and strengthen collaboration within the CRVS
- Development and implementation of a policy for continuous training for district registrars, vital statisticians, medical personnel, records personnel, and users of the CRVS
- Public education and awareness
- Monitoring and evaluation. Must be regular and ongoing to conduct data assessments e.g. possible inclusion of deceased name in census questionnaire.
