- ** The 10 years is the recent practice, in the years 1963 to 1971 however, Economic Surveys were conducted annually (except for 1970). Coverage was principally in the divisions of Mining and Quarrying, Manufacturing, Construction, Electricity, Gas and Water. The next census thereafter was the 1989 Census of Business Establishments (COBE) and covered
- Mining and Quarrying;
- Manufacturing;
- Electricity, Gas and Water Supply;
- Construction:
- Wholesale and Retail Trade;
- Hotels and Restaurants:
- Transport and Communications;
- Other Business and Personal Services.

The most recent Economic Census was the Uganda Business Inquiry (UBI) for 2000/01 and covered all the sectors covered in 1989 and in addition covered Large Scale Commercial Agriculture, Finance and Insurance.

***- In our surveys we applied a threshold in terms of employment. The threshold for the surveys/censuses for the years 1963, 1964, 1966, 1967, 1968 and 1969 was establishments employing at least 10 people. In the years 1965, 1971 and 1989 the threshold was establishments employing at least 5 people. In the 2000/01 UBI, following the compilation of a business register covering establishments with fixed premises in urban areas enganging at least 1 person, the coverage included establishments below 5 employees on sample basis.
