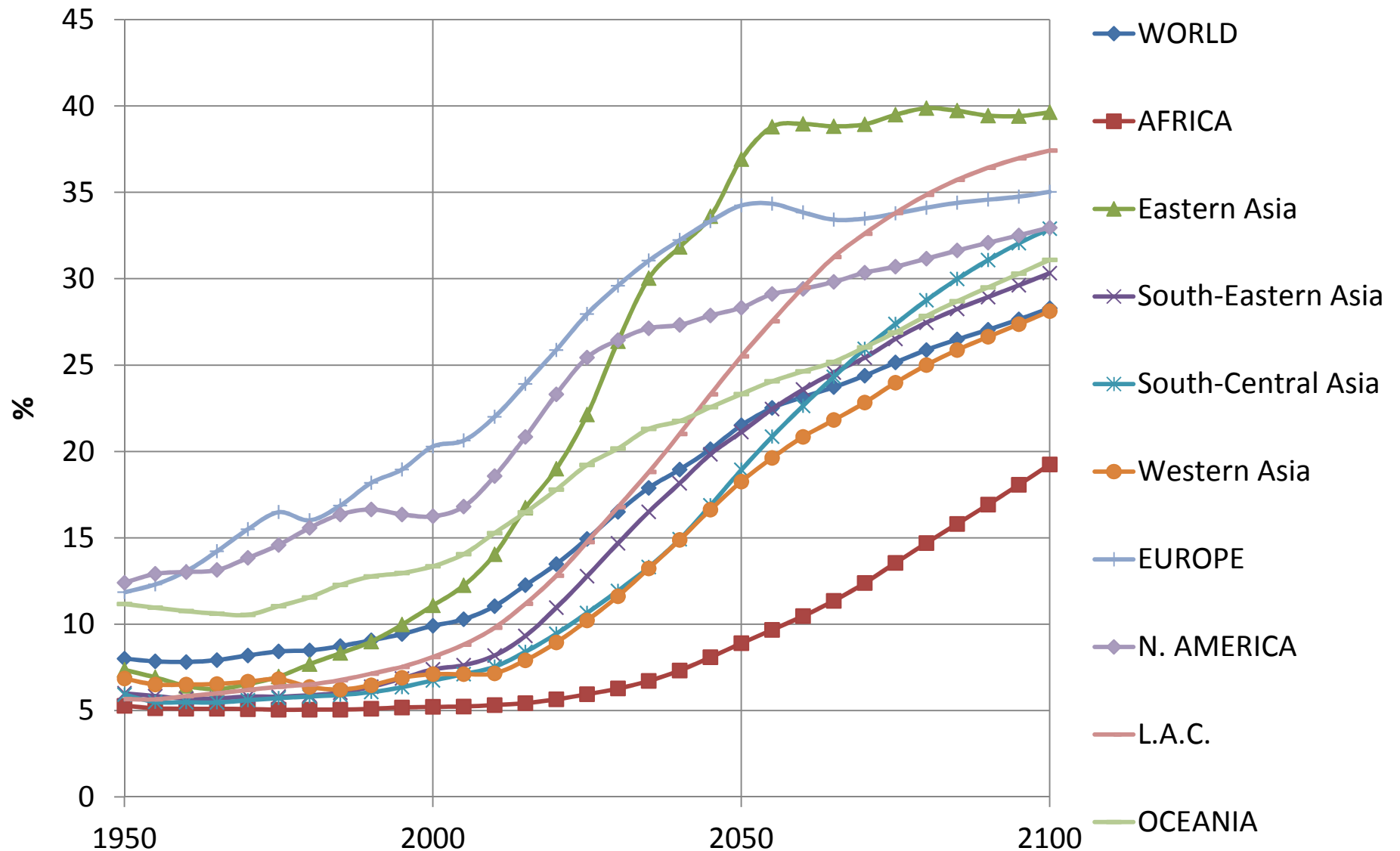

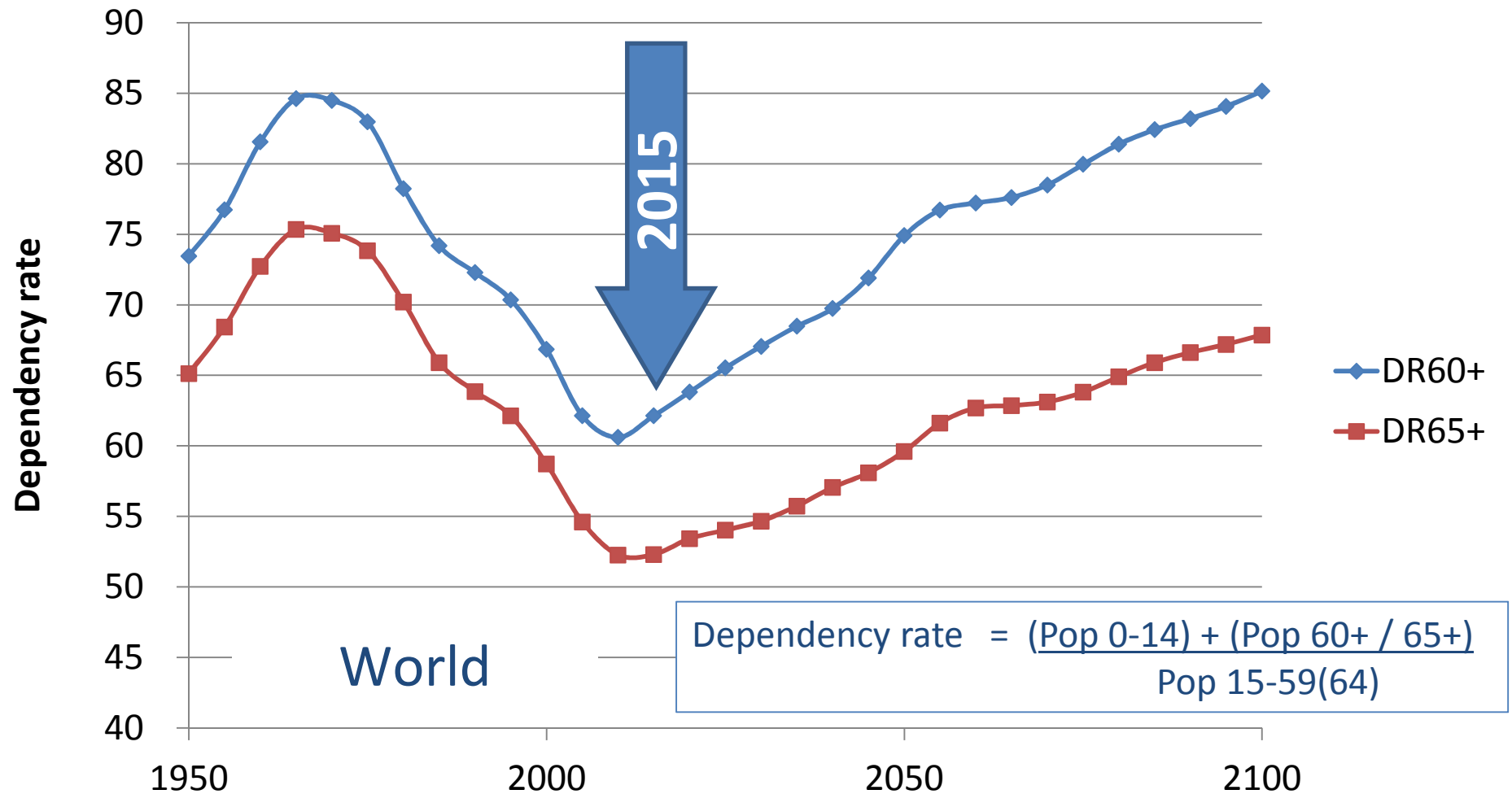
Proportion 60+

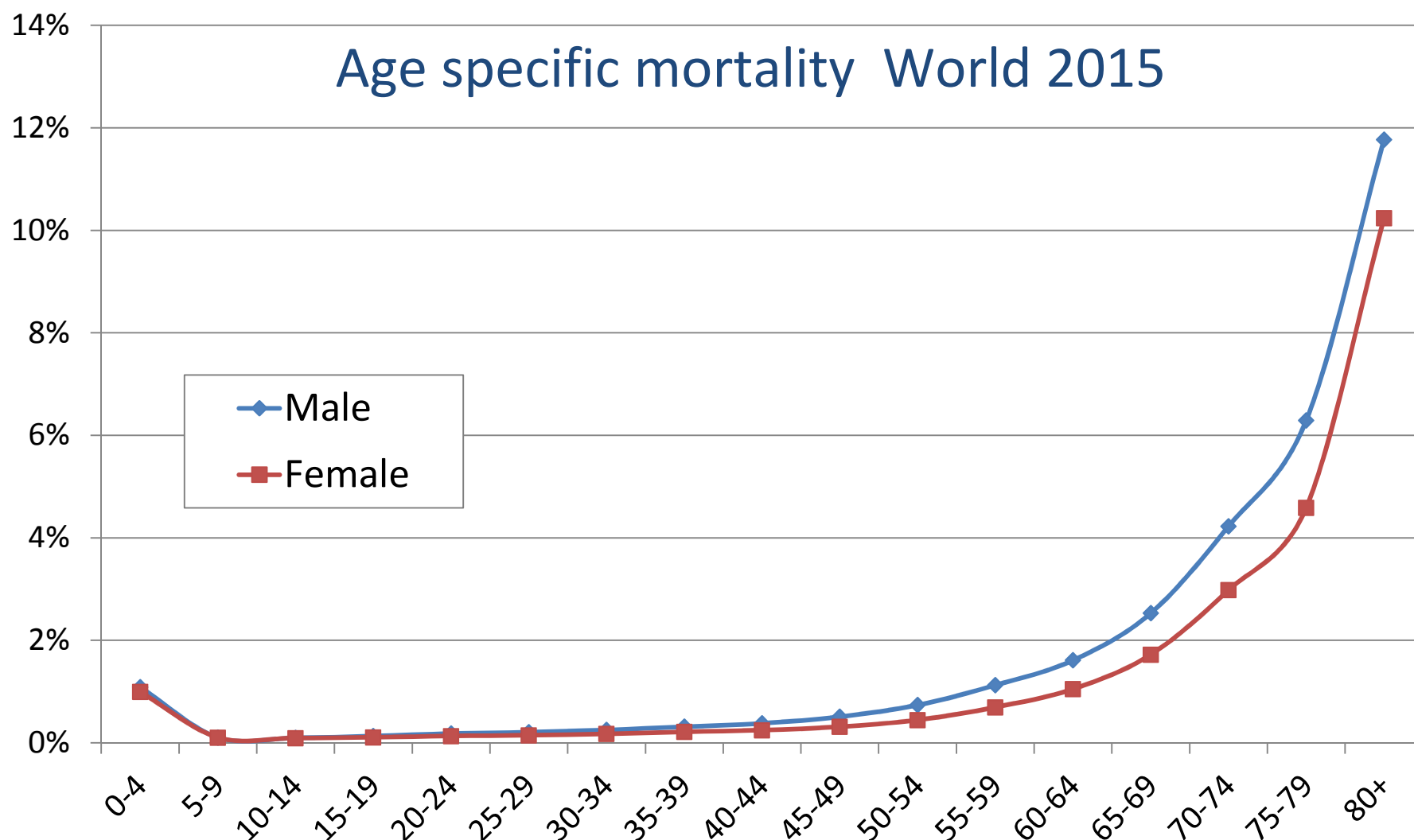
Now at the turning point

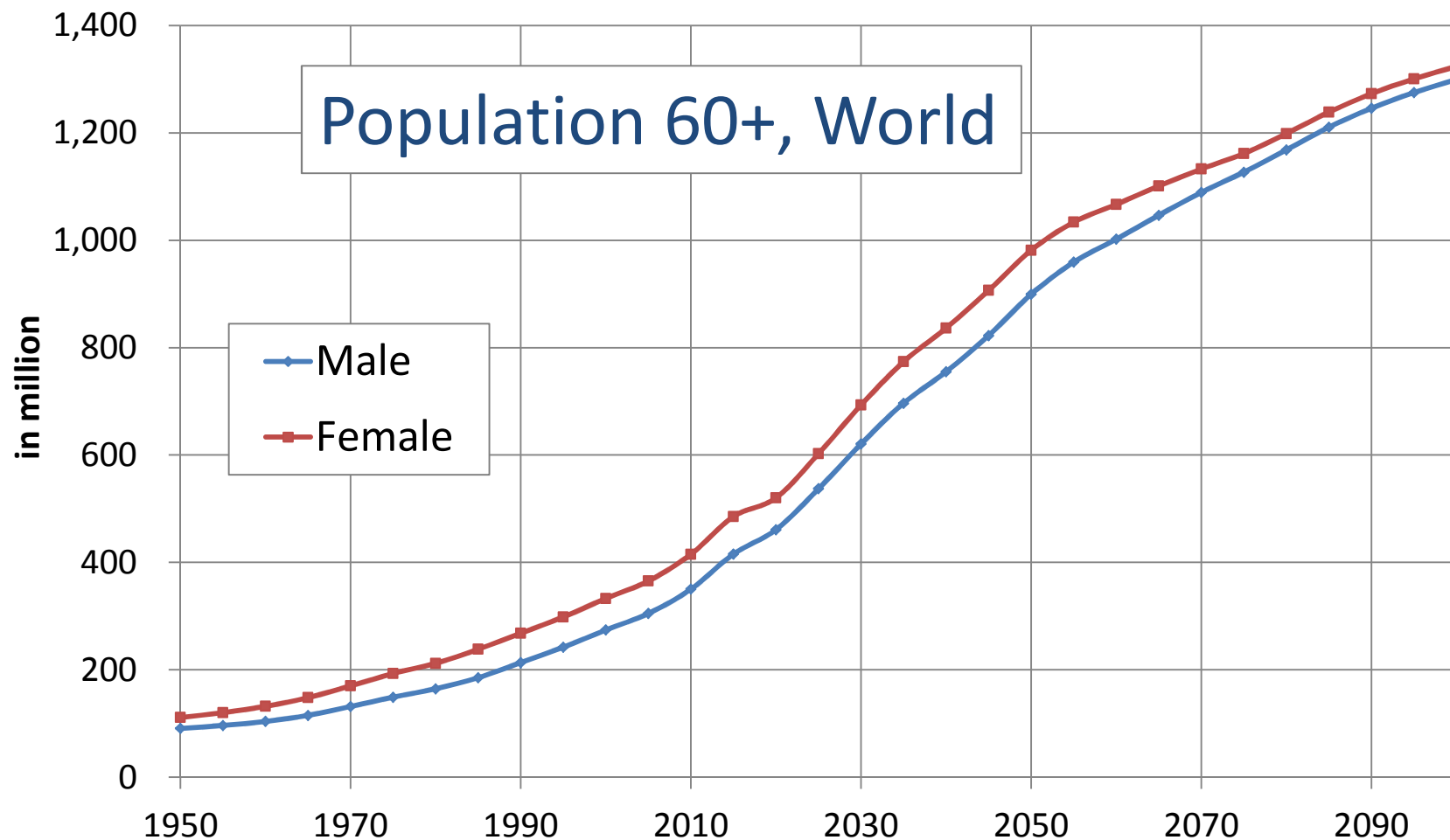
Lower mortality of women compared to men



Note : Mortality = Number of death 2010-2015 / 5 / Total population of 2015

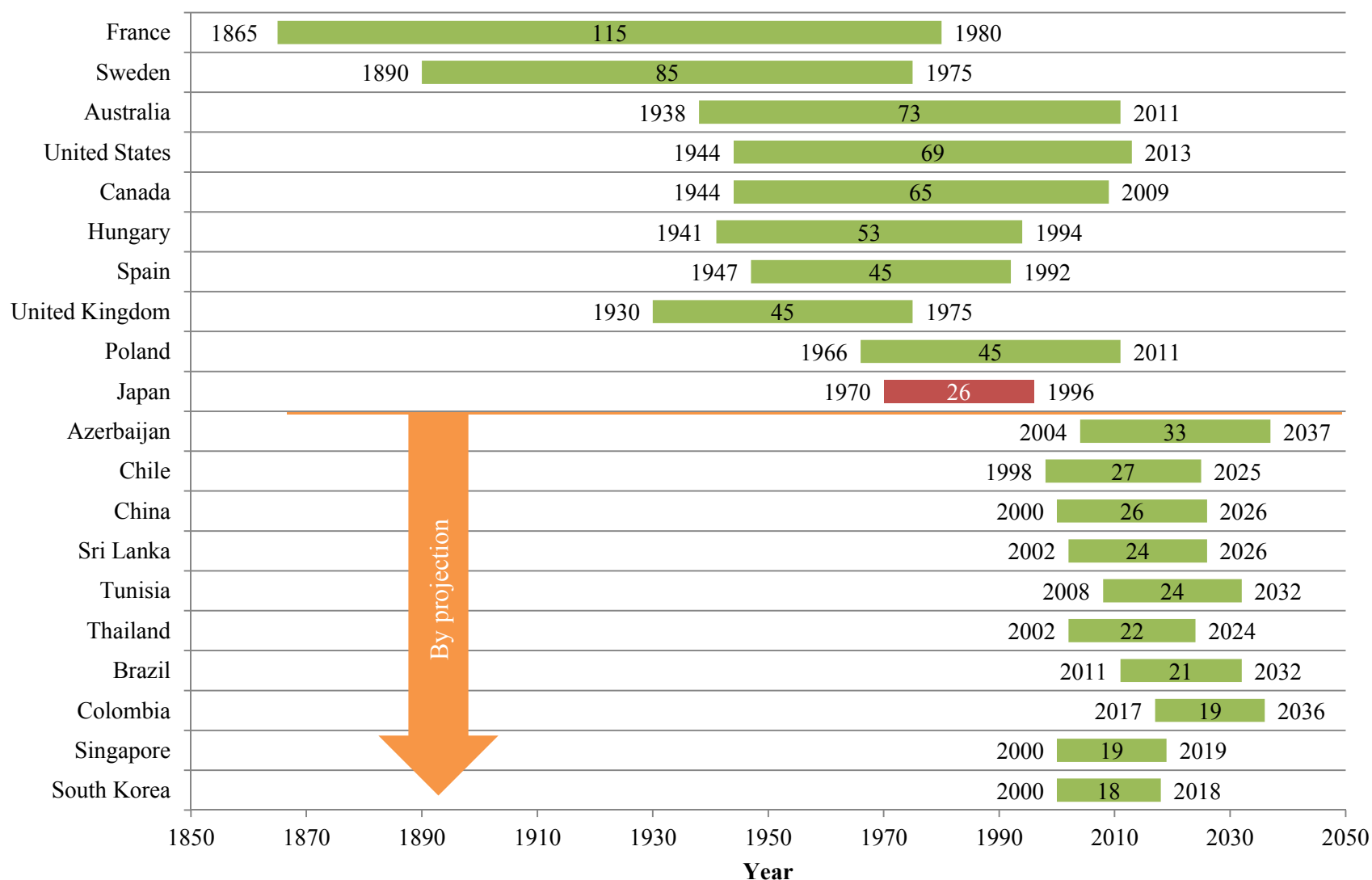

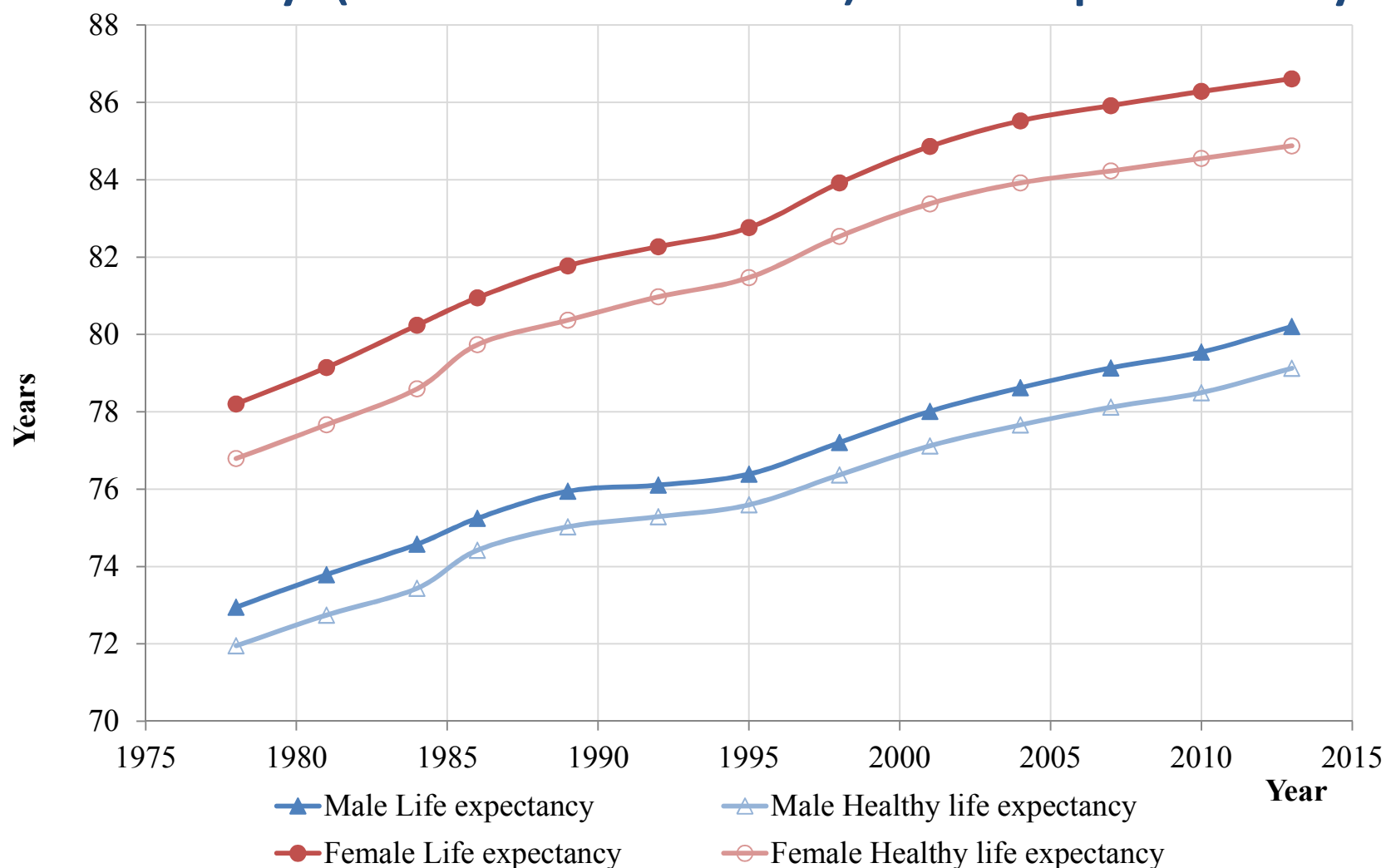
The time required from aging rate 7% to 14%

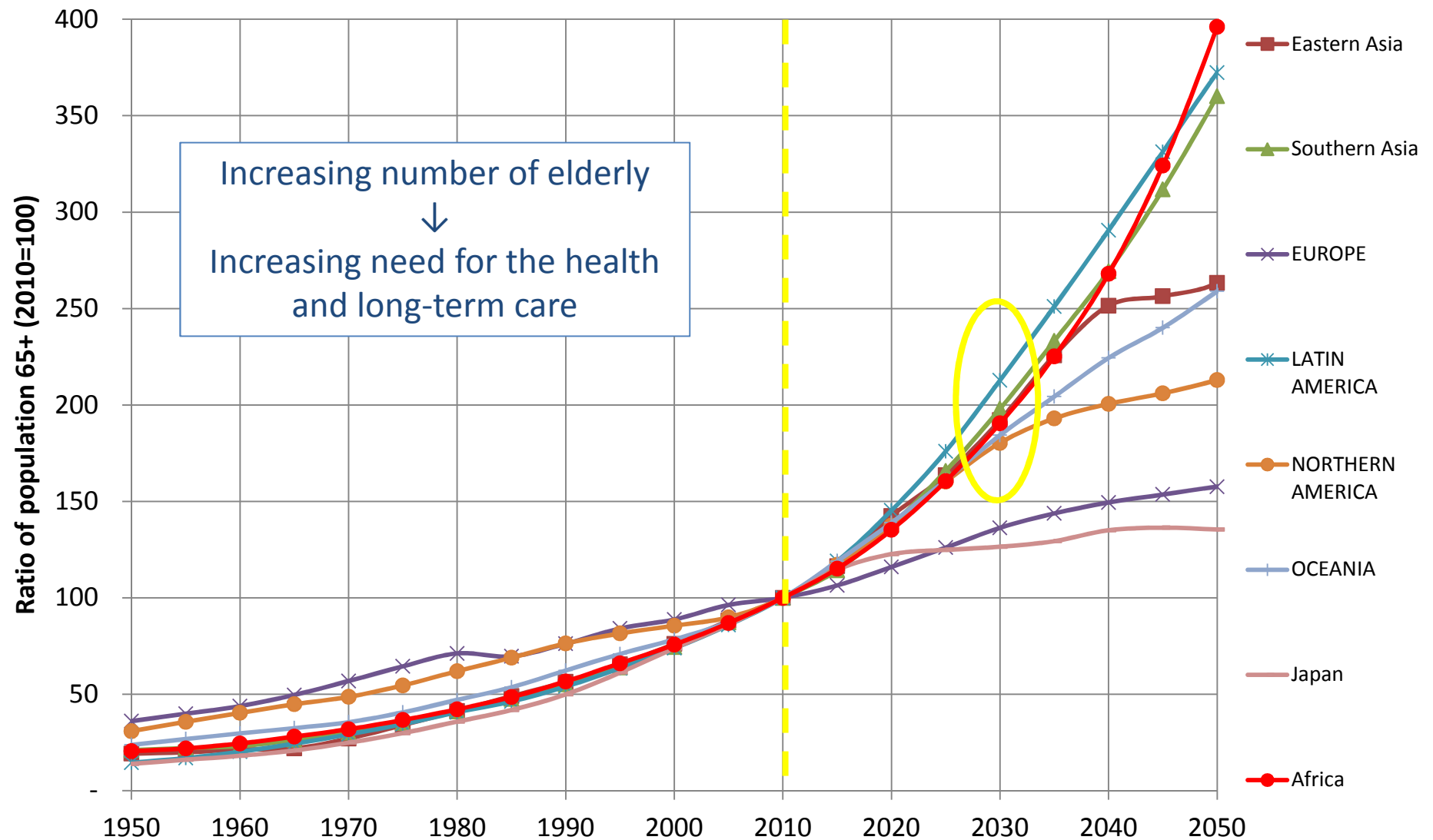

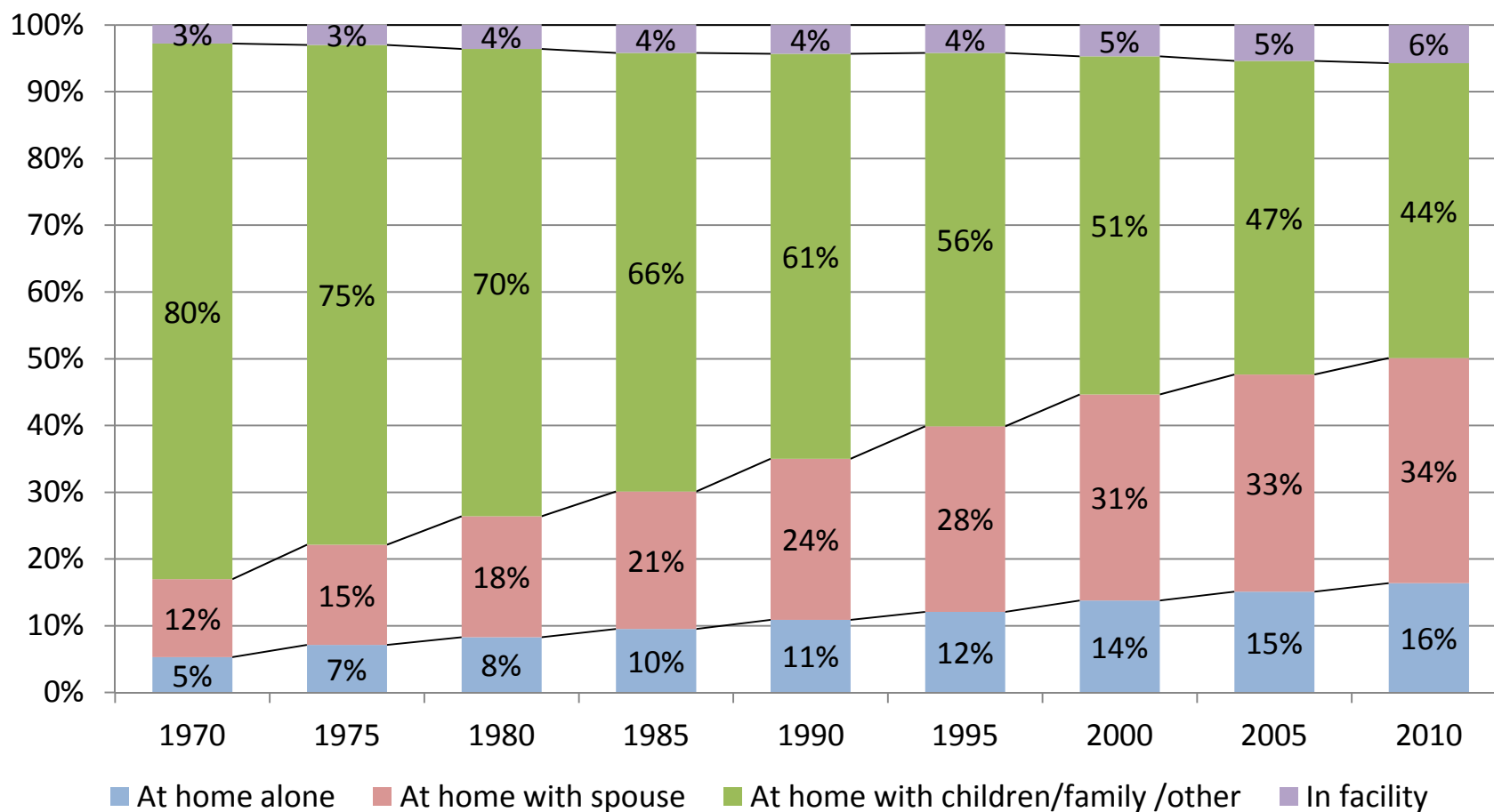
Population 65+ 1950-2050

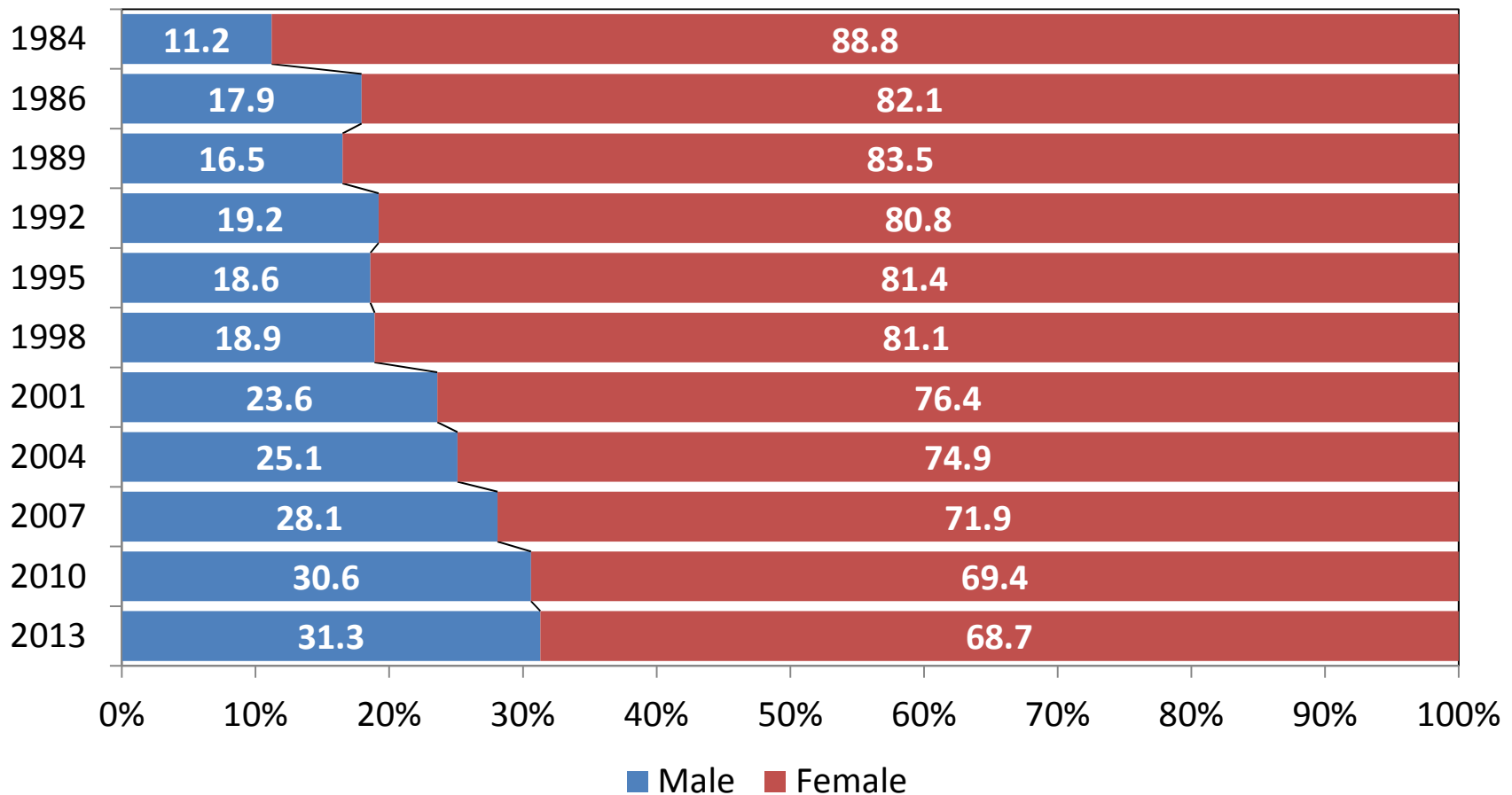
Living arrangement for the persons aged 65 years or older in Japan (2010)

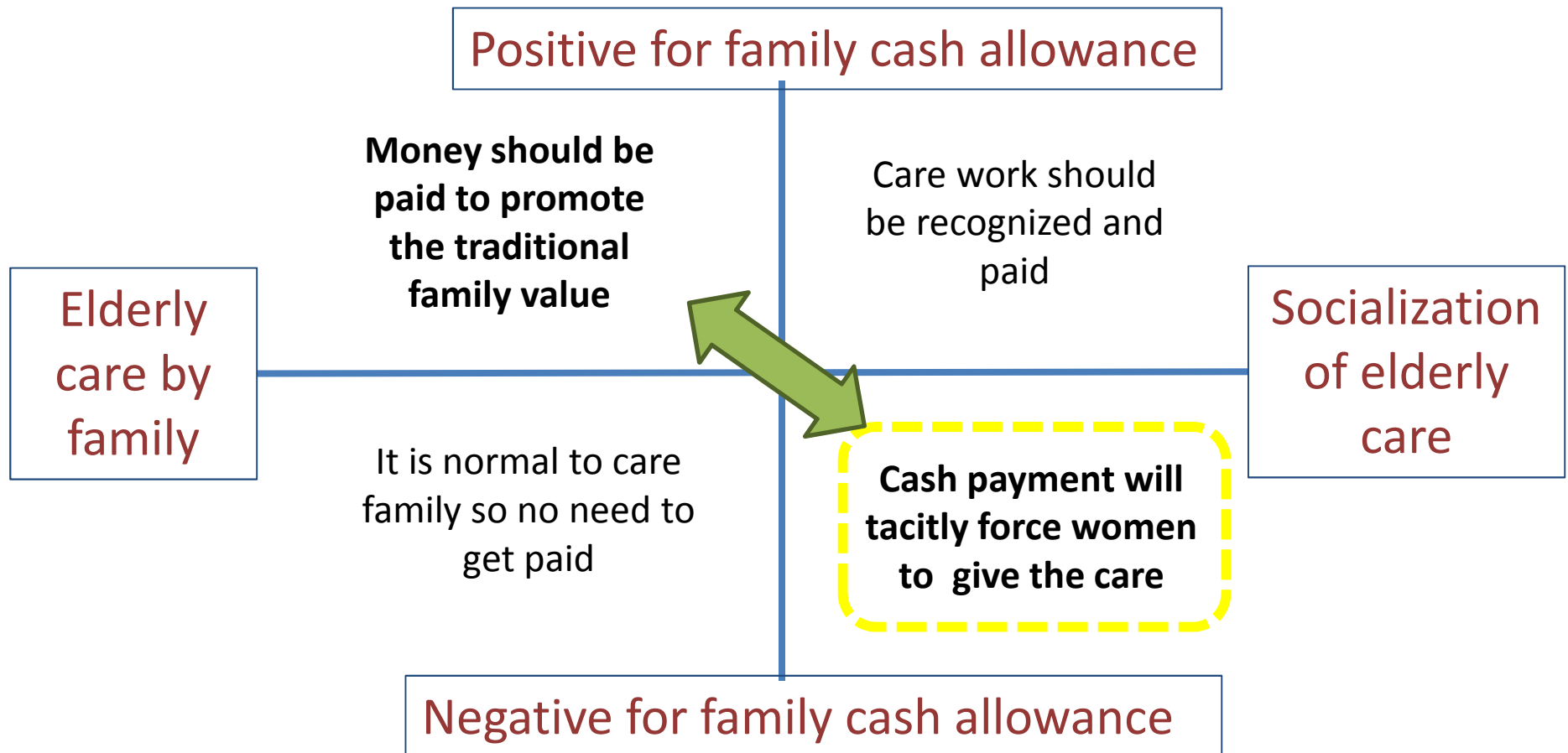
The women as the main family carer
