What we had?



PNAD National Household Survey (unpaid domestic work and unpaid care)

Number of people who perform household tasks is investigated since 1992.

Number of hours per week devoted to household tasks **and care** is available since 2001.

It is considered household tasks: Pack up and clear all or part of the house; Cooking or preparing food; ironing; washing clothes or dishes, using, or not, electrical appliances; Manage domestic workers in the performance of household tasks; Taking care of children; Clean the yard.

Restrictions:

- There is no information about non-productive/personal activities: learning; socializing, community participation and religious practice; culture, leisure and sports practice; self-care and maintenance.
- Hours devoted to household tasks and care are grouped together.




Continuous PNAD National Household Survey (Pilot test 2009)

Continuous PNAD Sample	211,344 households
Time Use sample	10,092 households (Test inside of a Test with 40,950 households)
Reference period	4th quarter of 2009
TU Universe	People aged 10+ years old
Geographical scope	Pará (North), Pernambuco (Northeast), São Paulo (Southeast), Rio Grande do Sul (South) and the Federal District (Midwest)
Activity classification used	ICATUS 2005
Operational instruments	24 hours-diary on paper as memory support and personal interview with mobile personal digital assistant (PDA). Time periods: 15 in 15 minutes

- It is important to note that the objective of the 2009 Pilot Survey was just check for errors and problems and, consequently, appropriate necessary corrections and adjustments in methodology in the field and in the collection instrument to be carried out in a future TUS to be implemented by IBGE.
- Although it has gains being a module on the LFS, because of the extensive questionnaire about employment and forms of work, the LFS has its own dynamics which implicates losses for a well conducted TUS, especially on the topics not covered by the LFS as personal activities.
- At 2009 TUS Pilot, we had low percentage of people registering activities as study, culture, playing games and physical activities (less than 15%). For a sample survey with federative results in Brazil maybe the results on this topic will be aggregated. It may function as coverage questions, but probably not for dissemination on this detailed form.



- We also propose the construction of a relational matrix to understand "who is caring of whom". It still a problem on PNADC because it is only possible to collect the information of whom is giving care and whom is receiving, but not for each care. Also, the tests indicated difficulties to collect the number of hours dedicated to care and household tasks separatedly.
- Other learning is related to the question of displacement between home and work. This shift was prioritized over other movements made by people for different activities, considering that, in the questionnaire, it would be difficult to address all types of displacements carried out. But these activities are difficult to collect because, some times, this displacement is done with multiple destinies, e.g., let the children on school before going to work.
- Based on total records without coding on 2009 Pilot, it can be observed that the displacement activities are among the most difficult to be captured as they often are confused with the activities to which they relate or do not report the purpose of displacement.



• Finally, we observed cases where it was unclear whether the informant is conducting a pastime activity or main job, as with sewing, fishing, feeding animals, etc. Homeworks are also often described in aggregate form, without specifying what type of activity the informant was performing: if ironing, washing dishes, etc. Some activities are without classification suggestion because they not contain in its descriptor minimal enough information.

General Comments: ICATUS 2016



-The group of activities related to the use of mass communication media (ICT) within a larger group of culture, leisure and sport: we have no clarity whether it is appropriate, since currently many activities are mediated by these technologies (e.g. *Candy Crush* on the tablet or phone is 82 - or 84 games)?

- The updated version of the Draft withdrew division 95 - activities related to reflection, relaxation, rest, which included the activity of smoking, meditate, among others. It was not clear which division absorbed these activities but, by deduction, it is assumed that these activities have been incorporated in the division 99 - Other Activities Personal Care and Maintenance. Smoking is personal care?
