ICANN

ICANN is a global organization that coordinates the Internet's unique identifier systems for worldwide public benefit, enabling a single, global interoperable Internet.

ICANN's inclusive multi-stakeholder model and community-developed policies facilitate billions of computers, phones, devices and people into one Internet.

Eligibility Criteria for IDN ccTLD Fast Track



- Country or territory must be listed in the International Standard ISO 3166-1.
- String must be a minimum of two characters long.
- Languages based on the Latin script are not eligible for the Fast Track Process.

General Requirements

- General String Criteria.
- Language and Script Criteria.
- Meaningfulness Requirement.
- Number of Strings per Country or Territory.
- Technical Strings Criteria.

How does UNGEGN help?

- As part of the Linguistic Process step, ICANN checks to see if the requested string is a meaningful representation of a country or territory name.
- UNGEGN has referred experts who review the information & provide a letter on whether the requested string meets the meaningfulness requirements.

How does UNGEGN help?

- Experts have assisted 3 requesting countries and territories with meaningful documentation to date.

Seventeen Months Later and....

Launched
Nov 16
2009!

- 34 unique requests received to date.
- 27 IDN ccTLD in Root Zone.
(17 countries/territories)
- 10 approved ready to apply for/in IANA delegation process.

gTLD Program Update

- Latest version of the proposed Applicant Guidebook posted on 15 April 2011.
- Revised definition of country name per consultations with Governmental Advisory Committee.
- Further GAC-Board consultation scheduled for 20 May 2011.
- possible ICANN Board consideration of process at ICANN meeting in Singapore on 20 June.

gTLD Program Update

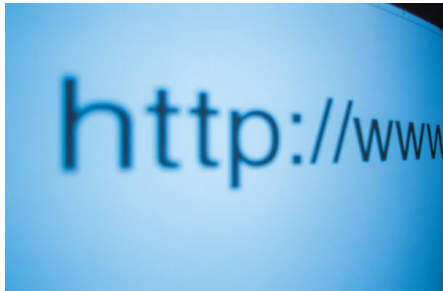
- A country name is defined as a name by which a country is commonly known, as demonstrated by evidence that the country is recognized by that name by an intergovernmental or treaty organization.
- Country names are still prohibited in the first round of the new gTLD process.
- ICANN's ccNSO is currently working on a Policy Development Process to address country & territory names.

gTLD Program Update



- City names, municipalities and other geographic names could be applied for in the new gTLD process.
- Please note that an application needs appropriate government support if a geographic string is applied for.
- The Internet is going to begin to look very different.
