Summary and introduction

In its 14th Meeting in Corfu, 23-25 May 2013, the UNGEGN Working Group on Exonyms was discussing the endonym/exonym divide and potential new definitions of the endonym and the exonym. At this Meeting 17 papers were presented highlighting the general theme by comprehensive and more specific approaches as well as by glances on documentation and use of exonyms in various countries.

The proceedings of this Meeting contain the papers presented as well as four additional articles, whose authors were prevented from attending the Meeting. It deserves to be mentioned that linguistic as well as geographical approaches are represented likewise, that views from four different continents (Africa, Asia, Australia & Oceania and Europe) are present and that besides the convenor of the Working Group on Exonyms the convenors of the Working Group on Toponymic Terminology (Staffan NYSTRÖM), the Working Group on Romanization Systems (Peeter PÄLL) and the Working Group on Evaluation and Implementation (Sungjae CHOO) contributed.

The book has been edited by Peter JORDAN and Paul WOODMAN, its layout has been provided by Florian PARTL at the Institute of Urban and Regional Research, Austrian Academy of Sciences, in Vienna.
