# UNITED NATIONS GROUP OF EXPERT ON GEOGRAPHICAL NAMES

## AFRICA SOUTH DIVISION REPORT

Twenty Ninth (29th) Session, Bangkok 25th April – 29th April 2016.

### Activities from member countries:

#### Botswana:

Botswana has been in the forefront following the passing of the resolution at the leadership forum, to resuscitate the “Botswana Place Names Commission (PNC),” and the development of a Legislative Framework for the PNC. The department of Surveys and Mapping through its newly formed Geographical Names Interim Committee has been working towards the realisation of the resolution, by compiling all historical documents on PNC to support the Ministry of Lands and Housing to take an informed decision on activities of Geographical Names in the country. In its effort to speed up the resuscitation process of Geographical Names Interim Committee has prepared proposals for a new PNC, how it should function and the members involved. In addition the Interim committee has contributed to the Naming of Streets and Towns document prepared by Local Government. These were done in alignment to the UNGEGN resolutions on names authorities.

Botswana as the Interim chair of the Africa South Division has made efforts to consult other regions on activities of the Geographical Names in their countries, but feedback has not been forthcoming. An invitation to attend

Meeting in Botswana has not materialised due non .response. The Gaborone Action Plan has also been sent to other members and comments are still awaited.

#### South Africa:

### APPOINTMENT OF THE SOUTH AFRICAN GEOGRAPHICAL NAMES COUNCIL

Call for nomination of the new South African Geographical Names Council was opened by the Minister. Letters requesting the Provincial MECs, Minister of Land Affairs and Rural Development, Minister of Cooperative Governance, Minister of Communication, Minister of Transport, Minister of Water Affairs and Forestry, CEO of National Heritage Council and PanSALB to nominate their representatives to the SAGNC for the new term of office were sent for their attention. The adverts for call for nomination on were posted on national newspapers e.g. Sunday Times, City Press, Beeld etc.

The Minister appointed a panel to assist the Chief Directorate: Heritage and the South African Geographical Names Secretariat with the selection. The Panel had its meeting to finalize recommendations for the Minister’s consideration.
