(4) The toponymic guidelines were appreciated in the report of the Third United Nations Regional Cartographic Conference for the Americas, 1985 (vol I, p. 18). The toponymic guidelines of the following countries were submitted to the Conference as documents by the Secretariat of the Conference:

Austria, Canada, Suriname, United States of America

The toponymic guidelines for France were submitted as a document by the French Institut géographique national. It is expeced that they will be published in volume II of the report of the Third United Nations Regional Cartographic Conference for the Americas.

According to the report of the United Nations Group of Experts on Geographical Names (UNGEGN) of the twelfth session, page 13, paragraph 56, five more topographic guidelines will be presented at the Eleventh Regional Cartographic Conference for Asia and the Pacific in 1987.

At the same twelfth session UNGEGN "strongly recommended that the toponymic guidelines should be published in one or more volumes of World Cartography".

At the twelfth session of UNGEGN it was suggested that the toponymic guidelines contain an indication regarding any distinction between geographical names and descriptive words by typographical means made in the maps of the individual countries. (See report of the UNGEGN, twelfth session).

In accordance with that report, the following additi was made to the title: "for international use".

## Summary

The Co-ordinator of the toponymic guidelines for international use by map editors and other editors gives a bibliographical list of the latest editions of the toponymic guidelines. He also reports on his activities as a co-ordinator of the project and on the response the toponymic guidelines have had within and outside UNGEGN.
