Experience at the fifteenth United Nations Regional Cartographic Conference for Asia and the Pacific

Paper submitted by the Permanent Committee on Geographic Information Systems Infrastructure for Asia and the Pacific**

Introduction

The fifteenth United Nations Regional Cartographic Conference for Asia and the Pacific (UNRCC-AP) was successfully held at Kuala Lumpur from 11 to 14 April 2000, receiving more than 200 participants from 34 countries/areas, sharing relevant information through 13 professional presentations by invited speakers and prioritizing and endorsing important resolutions for the promotion of geographic information in the region. This great success was due to the strong commitment and efforts of the host country, Malaysia, directed by Dato' Abdul Majid bin

Mohamed, ex-Director-General of Surveying Mapping Department and former President of PCGIAP. However, participants noticed a difference in the content and format of the meeting from previous meetings of PCGIAP and UNRCC-AP. The programme of the fifteenth UNRCC-AP was, for the first time, jointly planned and prepared by the United Nations and PCGIAP. The present paper summarizes the outline of the fifteenth UNRCC-AP, emphasizing how the regional forum of National Mapping Organizations assisted the activities of UNRCC in the Asia and Pacific region.

What is the Permanent Committee on Geographic Information Systems Infrastructure for Asia and the Pacific?

UNRCC-AP has been held every three years and has contributed greatly to the progress of the development of geographic information in the region.

However, the secretariat of UNRCC-AP was active only during the conference period and there was no single body responsible for the execution of resolutions during the period between the holding of the successive meetings of UNRCC-AP. The necessity of a permanent committee was evident.

Article 2 of the statutes of PCGIAP states that “The Committee has been established pursuant to resolution 16 of the thirteenth United Nations Regional Cartographic Conference for Asia and the Pacific (Beijing 1994) and shall operate under the purview of the United Nations Regional Cartographic Conference for Asia and the Pacific (UNRCC-AP) and submit its report and recommendations to that Conference”.

Pursuant to this mandate, PCGIAP held its first meeting in 1995, inviting the directorates of national survey and mapping organizations or equivalent national agencies of the nations from Asia and the Pacific, and established the following organization structure, to work continuously.

- Executive Board
 - President, Vice-President and Secretary (who leads the secretariat)
 - Board members (up to seven representatives)
- Working groups
 - Chair and Vice-Chair
 - Working group members

To confirm progress of the work of the committee, members meet once a year and Executive Board members meet once every six months. The committee members also participate in related international meetings in the name of PCGIAP and pursue liaison activities. The working groups execute their work plans endorsed by the Executive Board and the Secretary and secretariat assist the overall activities of PCGIAP directed by the President and Vice-President.

With the success of the fifteenth UNRCC-AP with PCGIAP involvement, the concept of a permanent committee has been validated.

How PCGIAP is incorporated at the fifteenth UNRCC-AP

The PCGIAP meeting was incorporated for the first time in the fifteenth UNRCC-AP under the theme: “Fifteenth UNRCC-AP — A Milestone for Sustainable Development”.

UNRCC-AP is held every three years, the fourteenth UNRCC-AP having been held in Bangkok in February 1997. In Bangkok a number of resolutions charged the PCGIAP with carrying out certain actions. The fifteenth UNRCC-AP provided the opportunity to report on the status of these resolutions and to report on and assess the considerable progress made by PCGIAP working groups towards the development of the Asia-Pacific Spatial Data Infrastructure (APSDI).

The fourteenth UNRCC-AP recommended that the fifteenth Conference have a primary focus on the continued and strengthened contribution of geographic information (from PCGIAP’s core activities of surveying, mapping and charting) in support of the implementation of Agenda 21 and its emphasis on sustainable development. The United Nations, PCGIAP and invited speakers related their reports and presentations to the support being provided to sustainable development through geographic information activities.

Each member State of PCGIAP was invited by the United Nations to form a delegation to the meeting, and experts in surveying, mapping, GIS and related activities were invited as guest speakers. Countries outside the region also participated and a large number of observers were in attendance. United Nations representation was from the Economic and Social Council, the Statistics Division and the Economic and Social Commission for Asia and the Pacific (ESCAP).

Twenty-six countries in the region and eight from outside attended. There were over 100 participants from the 34 countries and close to 100 observers, as well as 13 invited speakers.

Programme of the fifteenth United Nations Regional Cartographic Conference for Asia and the Pacific

The programme of the fifteenth UNRCC-AP is described in both the official United Nations report

(E/CONF.92/1) and the report on the proceedings prepared by PCGIAP (www.pcgiap.org/kl/klrep.htm). They shed light on what happened at Kuala Lumpur from two points of view. The fifteenth UNRCC-AP was successful in providing new contents in the conventional format of United Nations meetings by joint cooperation between the United Nations and PCGIAP.

The largest differences were:

1. The strong emphasis on invited papers from representatives of international bodies and experts in related fields. This well-balanced programme was mainly developed by Bob Irwin, member of the former secretariat of PCGIAP, i.e. the Australian Surveying and Land Information Group.
2. The fifteenth UNRCC-AP, incorporating the 6th PCGIAP meeting, enabled the agendas of both meetings to be run in tandem. It should be noted that there was no independent meeting of PCGIAP except for the PCGIAP Executive Board meeting.
