





In Minimum Set but not in SDG



- LFP (ind 3), Status in employment (ind 4/5/6), parttime employment (ind 14), employment of persons with children (Ind 15)
- Education indicators (enrolment, completion rate, educational attainment, field of study, women among tertiary teachers/professors)?
- % obese (ind 38), life expectancy at 60 (ind 41)
- Women in ministerial positions (ind 43); among police officers (ind 46); and among judges (ind 47)
