Goal 3 - Ensure healthy lives and promote well-being for all at all ages

- 3.7.1 Proportion of women of reproductive age (aged 15-49 years) who have their need for family planning satisfied with modern methods
- 3.7.2 Adolescent birth rate (aged 10-14 years; aged 15-19 years) per 1,000 women in that age group










U.S. Reporting Status for Global Indicators
