

## Implementation of the global gender statistics programme

## Minimum set of indicators

- Revisions based on discussion.
- Issues to be addressed:
  - Migration
  - Environment
  - Institutional mechanisms
  - Sections E, J and K of Beijing
    - Armed conflict
    - Stereotyping of women
    - Gender inequality in managing and safeguarding environment
  - Inequalities (e.g., Ethnic, geographic, disability, income)

## Steps for the minimum set

- Step 1: Present to the Statistical Commission
- Step 2: Undertake international compilation based on structure and timeline as agreed by agencies
- Step 3: Methodological development on Tier 3, including discussion at the Global Forum on Gender Statistics

## Busan Initiative

- Reconciled two sets of indicators (OECD and IAE-GS)
- Proposal to expand the scope of the text to be incorporated into the proposed Busan Action Plan for statistics, including:
  - Full minimum set covering all domains
  - Strengthen all data collection needs, with a special focus to be given to time use surveys, violence against women surveys and issues related to entrepreneurship
  - Create a global fund to assist countries to develop capacity to produce gender statistics, to be managed by UN Women in collaboration with UNSD

## Global Fund

- UN Women, in collaboration with UNSD (IAEG-GS)
  - Advisory services
  - Technical assistance
  - Training

## Manual

- Incorporate comments from countries and agencies
- Countries and agencies to provide inputs and examples to UNSD before the end of November
- Expand the manual to include:
  - Metadata and guide for compilation of the minimum set of indicators
  - Annex on training
  - Expand section on Household surveys to include guide on engendering MICs and DHS
- Explore ways of producing the expanded manual as an inter-agency collaborative effort (UN Women, UNSD, UNFPA, World Bank taking the lead and providing resources)

## Common questionnaire

- Objectives and content to be revised based on discussion of the subgroup (by end of November)
- Regional commissions to undertake collection of information in their regions (by end of February)
- UNSD to compile the results and present preliminary report at the Forum (by end of March)
