1) Introduction

- a) The Titchfield City Group on Ageing and Age-disaggregated statistics was created at the forty-ninth session of the United Nations Statistical Commission (UNSC) in March 2018 (ref 49/118).
- b) The purpose and overall objective of the Titchfield Group supports the United Nations 2030 Agenda for Sustainable Development, by identifying gaps and developing international guidance and methods for producing both data disaggregated by age and ageing-related data across the life course. This work is carried out in collaboration with United Nations (UN) bodies, National Statistics Offices and other organizations concerned with multiple aspects of ageing-related and age-disaggregated statistics. The Titchfield Group aims to lead the dissemination of good practices across the world and facilitate collaboration.

- d) The [United Nations Statistical Commission Forty-ninth session](#), 6–9 March 2018. Report of the United Kingdom of Great Britain and Northern Ireland on ageing-related statistics and age-disaggregated data agreed the Group will initially operate for a five-year period, from 2018 to 2023, after which time a review of its substantive work as well as its methods of work will be carried out (E/CN.3/2018/19 A.6).
- e) This report details the both the method of review and the resulting outcomes.

2) Activities of 2022 - 2023

- a) The Titchfield Group commenced a gaps analysis in 2023. This exercise identified the expected outcomes at the start of the programme, the current state of work, and the differences between the two states.

- b) The base for the desired state was the [United Nations Statistical Commission Forty-ninth session](#), 6–9 March 2018. Report of the United Kingdom of Great Britain and Northern Ireland on ageing-related statistics and age-disaggregated data.
- c) The desired states were compared to the progress of the group and assigned a RAG (Red-Amber-Green) status.
 - i) Red Status was assigned where the desired state was not included in the current work strands or operation of the group. Action is required to take this desired state forward. These have been marked as ‘Recommendations’ for action in the below table of Gaps Analysis.
 - ii) Amber Status was assigned where the desired state was included in the current work strands or operation but will not fulfil the requirements or is not being progressed at the present time. Action is required to take this desired state forward. These have been marked as ‘Recommendations’ for action in the below table of Gaps Analysis.
 - iii) Green Status was assigned where the desired state was included in current work strands or operation. The work planned will fulfil requirements of the desired state. No further action is needed. These have been marked as ‘On Target’ in the below table of Gaps Analysis.

- e) The assessment of gaps against the desired state was completed with thanks to a representative subgroup of the Titchfield City Group on Ageing Steering Group. This method ensured current progress on work strands continued uninterrupted. It also avoided potential repetition of work completed in planning and outlining the requirements of the work strands. The six work strands are as follows:
 - i) Assessment of current evidence and identifying gaps
 - ii) Conceptual and analytical framework
 - iii) Standardisation and harmonisation guidelines
 - iv) Horizon scanning / future needs of data users
 - v) Age-disaggregation and ageing-related statistics for the Sustainable Development Goals Indicator Framework
 - vi) Sharing information on good practices; Development of a platform for sharing information
- f) The interlinkage of the work strands is recognised, not only within the group, but globally. This five-year review has the added benefit of assuring the work of the group is in line with international advancements, and not duplicating work being progressed by other agencies and organizations.
- g) A subgroup of the Steering Group was formed in 2023. In a series of virtual workshops, the subgroup reviewed the Red and Amber rated desired states and made recommendations to progress the work.
- h) All resulting gaps were reviewed at the 2023 technical meeting, with final proposals for the way forward agreed by the Titchfield Group on Ageing Steering Group in October 2023. A report of the meeting can be found [here](#).

3) Endorsement and actions of the Steering Group

- a) The Titchfield Group on Ageing Steering Group considered the products of the work strands in light of the discussion and decisions made in the 2023 technical meeting, the horizon scanning activity, and the conclusion of the gaps analysis review of the first five years of the Titchfield Group.

b) The Steering Group agreed the following work strands objectives are being taken forward as planned, providing the following gaps are addressed:

i) Assessment of current evidence and identifying gaps

(1) The steering group acknowledges the work of Data Gap Analysis for SDG Implementation using Policy Priorities and Indicators for Ageing and Older Persons. The work of the technical meeting highlighted some gaps to be taken forward in 2024. These include analysis on country positions and ways of working that can be shared on successes.

ii) Conceptual and analytical framework for comprehensive information on older adults

(1) The Titchfield Group acknowledges the work on Making older persons visible in the Sustainable Development Goal's monitoring framework and indicators is related to Sustainable Development Goals only. The work of the technical meeting agreed the challenges related to Ageing are broader than these indicators alone. The group propose to build on the work available and include in the work planned for publication in 2024.

iii) Standardisation and Harmonisation Guidelines

(1) The Titchfield Group acknowledges the work to date. After assessment of the work completed, and feedback from the workshop at the 2023 technical meeting in Geneva, the steering group propose to build on the materials available globally.

(2) The Group agreed to use the collection of data from the work strand assessing current evidence and identifying gaps and provide guidance on barriers in relation to older persons. The work will also include guidance on harmonisation across and between time. The strand will review which Strategic Development Goals can be harmonised, along with challenges and guidance. It was also proposed to produce guidance on the harmonisation to alternative measures of ageing.


c) The Steering group has reviewed the gaps analysis with regard to the following work strands and agrees the objectives have been satisfied either within current work strands or other agencies.


d) The Steering Group ratifies the decision to close the below work strands subject to the above being taken forward. Further information on rationale can be found in the below gaps analysis.
