Article 12, of statistical law states:

- National Statistical System shall be coordinated by INSTAT to ensure that all official statistics producers observe the standards, concepts, definitions, classifications and statistical methodologies;
- INSTAT shall be responsible for the coordination of the statistical programming and reporting, monitoring quality, methodologies, data transmission and communication on the activities of the National Statistical System in the entire country





#### SDNSS 2020-2030 developed:

- The transformation process towards European Union (EU) integration;
- Implementation of the recommendations of the EU for Albanian alignment with the acquis communautaire (acquis) in statistics;
- Continuous increase of demand for higher quantity and quality of data from users at the national, European and international level for policy, planning and monitoring purposes;
- Rapid changes in the Information and Communications Technology (ICT) environment for statistics; and
- The Law No.17/2018 on Official Statistics adopted on 5 April 2018 (Statistics Law 2018).





- Objective 3: Produce all official statistics to a high level of quality, meeting accepted European and international standards:
  - Improve the quality of administrative data and records by supplier institutions
  - Build, maintain and promote a quality management and quality control system for the NSS
