
- The African Charter on statistics

#### Regional initiatives

- SHaSA, a common framework to address the challenges of:
  - producing quality statistics
  - coordinating the African Statistical System
  - enhancing institutional capacities, and
  - developing a statistics culture across the continent
- SHaSA II
  - Vision: "An efficient statistical system that generates reliable, harmonized and timely statistical information covering all dimensions of political, economic, social, environmental and cultural development and integration of Africa."







#### Institutional/organizational levels

- Support modernization of national statistical legislation (statistics act)
  - coordination of the NSS
  - Coordination committee for official statistics discussion, review and coordination of ... Common quality assurance framework and common quality label... (common work programme, dissemination policy, statistical methodology and standards to apply, confidentiality rules, etc.)
- National multi-year statistical programme (NSDS):
  - development, implementation and evaluation
  - a focus on quality
  - aligned to SHaSA
