Dear Colleagues,

Global Consultation on draft guidance on quality assurance when using administrative and other data sources and on a Maturity Model on Quality Culture

At its fifty-fourth session (28 February-3 March 2023) the United Nations Statistical Commission tasked the Expert Group on National Quality Assurance Frameworks (EGNQAF) to support countries in the implementation of a national quality assurance framework throughout their national statistical system. ¹ In this regard, the EG-NQAF² established two subgroups:

- 1. A Subgroup on Administrative and Other Data Sources focused on providing practical and concise guidance and best practices for statistical agencies in assuring the quality of official statistics when administrative data sources, 'other' data sources or multiple data sources are used for the production of official statistics;
- 2. A Subgroup on Quality Culture focused on developing practical and concise guidance, suggesting a maturity model, and providing best practices, as applicable and feasible, on how a quality culture in official statistics can support the implementation of the national quality assurance framework at the national statistical office and throughout the national statistical system.

I am pleased to share with you for your review two draft guidance documents developed by the two Subgroups:
