Questionnaire on the implementation of quality assurance

In March 2019, the United Nations Statistical Commission adopted the United Nations National Quality Assurance Frameworks Manual for Official Statistics (Manual¹), including the recommendations contained therein (Decision 50/106²). The development of the Manual greatly benefitted from a country survey conducted in 2017 by the Expert Group on National Quality Assurance Frameworks.³ The survey showed that many countries had yet to implement a national quality assurance framework (NQAF). The Statistical Commission at its 52nd session in March 2021 tasked the Expert Group to conduct a follow-up survey to assess progress in the implementation of national quality assurance frameworks by national statistical systems.

In this regard, I invite your office to participate in the survey on the implementation of quality assurance that was developed by the Expert Group. I further invite you to share information on your national practices as indicated in the enclosed questionnaire. Please complete the survey on behalf of the whole national statistical system (NSS)⁴ and submit your response by <u>30 September 2022</u> at <u>https://www.surveymonkey.com/r/NQAF2022</u>. The questionnaire is also available in French and Spanish.⁵

The results of the survey will inform the Commission about the status of implementation of quality assurance in countries, and materials shared will be used to update the repository of quality assurance practices.⁶
