ISIC Rev.4

- Meeting of the Technical Subgroup on the International Standard Industrial Classification of All Economic Activities (TSG-ISIC) in New York 18-20 June 2019 discussed several issues with ISIC
- the TSG-ISIC concluded that these issues cannot be addressed within the current structure of ISIC. However, the extent of the changes to ISIC can be assessed only after a global consultation
- A global assessment was launched on 13 September 2019 to countries, international regional organizations and relevant expert groups
- Based on the results of the global assessment, the TSG ISIC will prepare a report to the Expert Group on International Statistical Classifications containing recommendations on the extent of the revision of ISIC



Initial list of issues

- Internet retail sales and e-Commerce sales
- Intermediaries in service activities
- Audio and video content distribution
- The distinction between wholesale and retail trade
- Factoryless goods producers (FGPs)
- Technology and the application of new technology
- Statistical units

Classification of Business Functions

- The classification of business function is being developed to better capture and reflect the organization of business functions within a multinational enterprise
- Building on the experience of the Eurostat International Sourcing Survey
- It is expected that
 - an expert group will be organized in the first half of 2020
 - global consultation on the business function classification
 - Submission to the Expert Group on International Classification for their endorsement
 - expected to be finalized towards the end of 2020



Harmonized Commodity Description and Coding System (HS)

- WCO Conference on the Future of the Harmonized System was held 2-3 May 2018
- Identified some factors that need to be considered in the revision of HS, such as globalisation and the rise of Global Value Chains and intermediate goods, and others
- Formulated a project to further examine potential areas of change for HS
- A follow-up WCO Committee meeting took place 23-26 September 2019 to take the review forward



Classification by Broad Economic Categories (BEC)

- 5th revision of the Classification by Broad Economic Categories was endorsed by the United Nations Statistical Commission in 2016 for use as an international statistical classification
- The BEC Rev. 5 was published in 2018 and is available at <https://unstats.un.org/unsd/trade/classifications/bec.asp>



Standard International Trade Classification (SITC)

- UNSD is in the process of circulating a proposal to undertake a 5th revision of the SITC in collaboration with the WCO in preparation of the forthcoming 2022 edition of the Harmonized Commodity Description and Coding System (HS 2022)
