

Overview of FITT Work Since February 2021

The FITT is currently assigned 17 research topics (14 were originally assigned) to prepare respective GNs for consideration.



The following 4 new topics were introduced, and lead authors and contributors assigned:

- F.15 "Debt Concessionality"
- F.16 "Subscription Rights"
- F.17 "Master Risk Participation Agreements"
- F.18 "Crypto Assets" (joint with the Digitalization Task Team)



F.11 "Treatment of Electricity Forwards" has been dropped.
