History

History

- 1. Consolidated Guidance Note that includes the issues of Digitalization and Informality and Informal cross-border flows.
- 2. Strong cooperation with the ILO Working Group for the Revision of the standards of statistics on informality.
- Discussion at meetings of the AEG, BOPCOM, and the ILO WG in Q4/2021 and large expert group consultation of national accountants, external sector statisticians and labour statisticians.
- 4. Global consultation concluded on 3 April 2022.







Respondents largely agree with the definition of informal productive activities; and






Overarching Framework

Respondents largely agree with the definition of informal productive activities; and




Respondents largely agree with the definition of the formal sector;

Respondents largely agree with the definition of the formal sector; the exclusion of underdeclared and undeclared production in the formal sector; and






Formal Sector

that formal sector enterprises can use informal labour inputs as part of their production and that these informal labour inputs are part of the informal economy.






Informal Sector

Respondents also agree with the revised definition of the informal sector.


- *Mainly* intended for the market

Respondents also largely agree with the description of the household ownuse production domain;






Household own-use production domain

Respondents also largely agree with the description of the household ownuse production domain; and


The exclusion of the following household production activities:

Dependent Contractors


Respondents largely agree that all dependent contractors should be treated as owners and operators of unincorporated household enterprises.

Respondents agree with the description of illegal activities in the guidance note;



3. Proposed Actions



Actions

Improve Clarity

Clarify, that the framework is not a tool to produce exhaustive measures of production.

Move the delineation of the non-observed economy and the informal economy from the annex to Section II: Background.

Clarify that the Task Team does not recommend that all countries need to compile data on all components of the informal economy.



Actions

Improve Clarity

Clarify that production in the formal sector is never informal.

- 1. Be explicit about the exclusion of production in the formal sector paragraphs.
- 2. Use informal labour inputs instead of informal productive activities in the formal sector paragraphs, Box 2, and Box 3.
- 3. Make minor changes to the decision tree




Actions

Decision Tree

Remove box on labour inputs in the formal sector and rename row to informal production.

The informal economy consists of all informal production and all informal labour inputs.



Supplementary Practical Recommendations

Will mainly consist of:

- · Guidance to compile statistics on the revised informal sector; and
- References to existing/upcoming guidance on:
 - unpaid household labour
 - labour accounts
 - non-profit institutions and volunteering
