



#### The Update to the GFSM 2014

- Objectives:
  - 1. Harmonization with other statistical standards
    - not only 2025 SNA and BPM7
    - also launched COFOG, SEEA CF, MFS updates
  - 2. Meeting user needs
- Intended outcome:
  - ► A new GFS manual (updating and replacing the GFSM 2014)
- Time required for update:
  - Aim: Updated manual by end-2027
- Who will be involved:
  - IMF-led project requiring extensive collaboration and consultation with statistical compilers and users worldwide







#### Governance

- IMF Statistics Department responsible overall
- Newly reconstituted GFS Advisory Committee (GFSAC) was established in late 2023
- GFSAC's role is to advise the IMF on GFS matters. The update of the GFSM 2014 is currently their key agenda item. They play a critical role and will review recommendations.
- Task Teams will provide the technical input and research on specific research projects – as with SNA and BPM updates
- New website established for the update to the GFSM 2014: Government Finance Statistics Manual (imf.org)

#### **Consultation-based Approach**

- The first Global consultation on the update to the GFSM 2014 closed in late July
  - Documents included
    - the proposed update processes and timeline
    - detailed information on the proposed research program
      - split between projects based on new SNA/BPM guidance and projects which are GFS-specific
- Global consultations throughout the update process as draft recommendations are reached and new manual is drafted
- Outreach is also expected to take place throughout the update in particular regional outreach
- Stakeholder engagement is critical to ensure a comprehensive and inclusive update to the GFSM 2014

### **Overview of Process and Timeline**

#### **Phases of Update Process**

- Research phase: to develop new guidance for each project in the research program
  - IMF staff led new guidance agreed in the context of SNA/BPM updates
    - recommendations on how to incorporate in GFSM
    - global circulation of proposals + final notice of decision
    - o aim to finalize by 2025Q2
  - Task Teams led additional GFS-specific topics identified
    - develop discussion notes for global consultation
    - proceed to propose recommendations
    - global circulation of proposals + final notice of decision
    - expected to conclude in mid-2026
- Drafting phase: to prepare the new manual (structure and content)
- Research and drafting phases overlap and are nonlinear

#### **Overview of Proposed Timeline**

Research Phase starts in 2024Q2. Final list of topics confirmed by 2024Q3 with low resource research projects advanced by 2025Q1



Drafting Phase starts in 2025Q1 with agreement of new manual structure



Final draft of new manual available for dissemination by end 2027.

#### **Overall Process for advancing research projects**

The **research and development stage** includes preparation of discussion notes.

The **stakeholder consultation stage** includes global consultation and analysis of feedback.

The **review and approval stage** includes preparation and endorsement of recommendations based on either: i) discussion notes; or ii) guidance notes prepared as part of the SNA/BPM updates.

• Discussion note (prepared by Task Team)

 Review and endorsement of discussion note for stakeholder consultation by GFSAC

 Global consultation on discussion note followed by publication of summary of consultation responses

# **Research Program**

#### Recap: Process for advancing research projects

#### **Key Points**

- The research phase includes three stages to advance the research program:
  - Stage 1: Research and development
  - Stage 2: Stakeholder consultation
  - Stage 3: Review and approval stage
- Research projects that are GFS-specific require the development of discussion notes and will start the process at the research and development stage. The research projects will be advanced through the Task Teams.
- Research projects for which SNA/BPM guidance notes exist, will start the process at the review and approval stage. The proposed GFS recommendations are prepared by IMF staff in parallel to the work of Task Teams.

#### **SNA/BPM Recommendations**

- 36 Research projects for which new SNA/BPM guidance developed
  - Includes clarification and issue notes and not only guidance notes
  - Some projects may result in a recommendation for no change to the guidance in GFSM but included for completeness
  - As part of the drafting phase a review of all changes in the SNA and BPM will also be conducted to identify any additional changes of GFS-relevance
- IMF staff will prepare a proposed recommendations document for each of the 36 projects highlighting the GFS implications from a compilation and fiscal analysis perspective.
- The preparation of proposed recommendations by IMF staff has started and drafting will be completed by the end of 2024. The process ends with the posting of decision notes by Q2 2025.

#### Research projects for delivery by Task Teams


- 32 Research projects that are GFS specific are assigned to four different task teams based on the subject.
- IMF staff has started to prepare Project Indication Documents (PIDs) for each project for the Task Teams.
- Task Teams will prepare two deliverables for each assigned research project, a discussion note, and a proposed recommendations document.
  - Discussion notes will convey the issues to encourage informed discussion and develop recommendations.
  - Proposed recommendations: Once global consultation on the discussion note has taken place, the Task Teams will prepare a proposed recommendations document.





#### **Respondents to Consultation**






## **Relationship with SNA/BPM Update**






Nearly half of respondents had either not been involved in the SNA/BPM Update or had only had a passing interest Just under 90% of respondents thought harmonization across macroeconomic statistical domains was of high importance

## **Proposed Research Program (cont.)**

Of the 32 GFS specific topics identified and included in consultation:

- 29 topics were considered by majority of respondents as being either "critically important" or "of significant importance"
- Other 3 topics (zakat, indigenous communities, SWFs) attracted less support as many respondents noted these were not relevant to their country

## **Takeaways from Consultation Responses**

- Broad support for the objectives of the GFSM Update and proposals around governance, process and timeline
- Some concerns over the size of the research program and the timeline to deliver it
  within
- Not all in the GFS community have been closely following the SNA and BPM updates with just under half of respondents not having followed updates
- Strong support for the individual research projects:
  - ➤ No other SNA/BPM guidance notes identified as being of relevance
  - ➤ 29 GFS-specific research projects topics were considered by majority of respondents as being either "critically important" or "of significant importance"

# **Next steps**

#### **Next milestones**

- IMF staff to progress the GFSM relevant changes arising from the SNA and BPM update. Expect draft conclusions to be posted next year for global review.
- Establishment of Task Teams to progress 32 GFS specific projects. Discussion notes will begin to consulted on in mid-2025.
- Consultation of the draft updated manual is expected in 2027.
- In addition to global consultations, we are planning outreach events to seek input from the IMF membership. We want to hear from you.
- Close consideration is given to the update of COFOG and the SEEA-CF both are related standards with relevance for GFS, and are updated to a similar timeline
