This workshop has been organized to help ECO countries establish or strengthen quarterly national accounts that meet users' needs.



QNA with a particular focus on production-based and expenditure-based gross domestic product (GDP) and the solutions to overcome the situations where the available data do not meet the requirements of the System of National Accounts (SNA) are among the issues which are going to be discussed in the workshop.

Let me seize the opportunity and mention that one of the priorities of the Statistical Centre of Iran is to develop its international relations and partnership in the capacity building programmes in order to empower statistical experts. In this strategy, neighboring countries and region especially ECO member states are of special importance. For this purpose, the Statistical Centre of Iran hosts a number of training workshops in collaboration with international statistical institutes such as UNFPA, UNSD, SIAP, UNESCAP and ECO every year and hosting of this workshop held in collaboration with ECO and UNSD is in line with the realization of this strategy.
