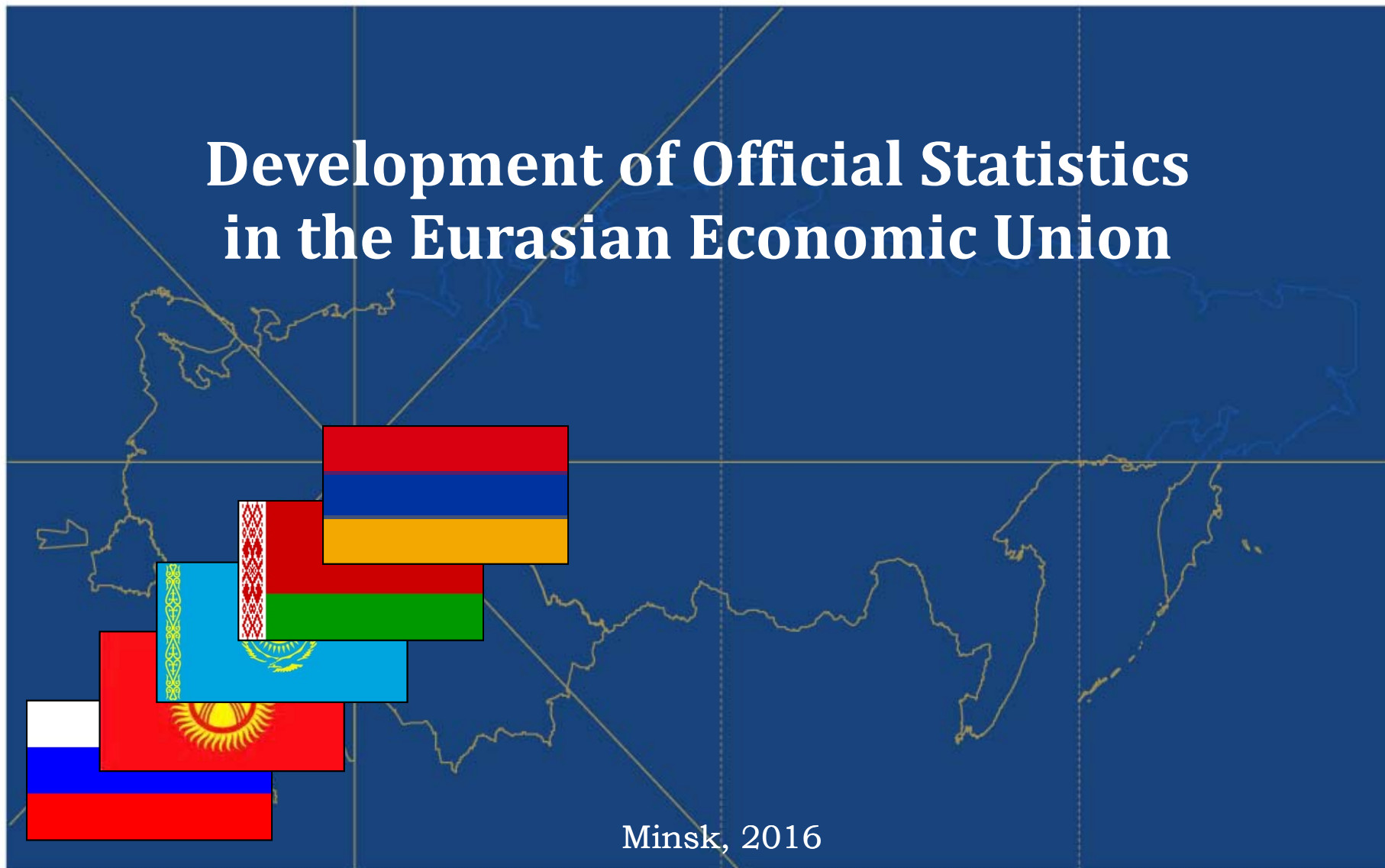




Development of Official Statistics in the Eurasian Economic Union

Legal base:

- Treaty on the Eurasian Economic Union (signed on May, 29, 2014);
- The Program of Statistical Works of the Eurasian Economic Commission (approved by the decision of the Board of the Eurasian Economic Commission annually);
- List of Statistics Indicators of the Eurasian Economic Commission and Questionnaires of Official Statistics for the Member States of the Eurasian Economic Union (approved by the decision of the Board of the Eurasian Economic Commission);
- Fundamental Principles of Official Statistics.

Key issues of the Program of Statistics Development in 2016 – 2020

➤ Free Movement of Goods

To compile the official statistics of the Eurasian Economic Union on volume indices of the foreign and mutual trade in goods at constant prices.



➤ Free Movement of Services

- To design of Classification of Services for the Single Service Market of the Eurasian Economic Union;
- To determine the methodology on evaluation of export and import of services in the Single Service Market of the Eurasian Economic Union;
- To determine the list of indicators by the four types of movement of services and methodology on their evaluation;
- To continue the implementation of the international standards: Balance of Payments and International Investment Position Manual (6th edition) and Manual on Statistics of International Trade in Services (2010);
- To continue work on mirror statistics.



➤ Free Movement of Capital

- To implement the OECD Benchmark Definition of Foreign Direct Investment (4th edition);
- To continue work on mirror statistics;
- To design the Register of financial institutions of the Eurasian Economic Union and to ensure its functioning by the interacting with national administrative and statistical registers;
- To design the legal basis for the interaction with currency-stock and commodity exchanges (to make changes in the Treaty of the Eurasian Economic Union).



➤ **Free Movement of Labour Force**

- Recommendations of the implementation of the Set of Key Indicators to monitor the national labour force market under the sample survey of the labour force;
- To create common criteria to define migrants in each Member State and approaches for data collection on migration.



2020 Population and Housing Census

- To design Module Set of Indicators on Employment and Migration to include in the census questionnaire.
