1. Name of Country : Czech Republic
2. Name of Agency Responsible for Economic Census : Czech Statistical Office
3. Description of Economic Census Objectives:
 - a/ source data for GDP — partially
 - b/ profile of economy — fully
4. Legal Mandate or Regulations for Conducting Economic Census :
 - a/ required by law — based on the Czech State Statistical Service Law
 - b/ responses required or on voluntary basis — required
 - c/ confidentiality — business register is partially public and partially confidential
5. Coverage
 - a/ which sectors are covered — all types of businesses in Business Register, sectors of agriculture, trade and construction covered by economic census
 - b/ statistical units — enterprise, Lj, KAU'
 - c/ number of businesses covered — 2 mil. in BR, cca 300 000 in census
6. Content
 - a/ variables collected — 24 items in BR (identifications, location, legal form, sector, validity, number of employees, equity, turnover, export, import)
 - b/ variety in sectors or industry — yes
 - c/ number of report form — 1 to 3
7. Frequency
Each 3 years in agriculture, each 5 years in trade and construction sectors, BR updated continuously
8. Methods
 - a/ combination of mail and enumeration
 - b/ use of administrativa data — yes for BR
 - c/ all businesses in censuses and BR, sample surveys connected
9. Data Products
BR is on-line available, results of censuses in publication and table forms
10. Uses and Users of Economic Census Data
 - a/ source data for GDP — yes
 - b/ benchmarking for GDP — yes

2 - Name of Agency Responsible For Economic Census :

Central Agency for public Mobilization and Statistics (CAPMAS) .

3 - Economic Census Objectives :

- Providing complete and detailed picture on the structure and characteristics of the different economic activities and their geographical distribution in different governorates .
- Measuring the contributing of each economic activity to the national product, and also the relative importance of each economic activity at both the regional and national levels .
- Providing comprehensive and detailed information on the value of inputs and outputs of every economic activity both at the regional and national levels .
- Providing detailed information on employment in the different economic activities geographically distributed .

4 - Regulations For Conducting Economic Census :

CAPMAS have carried out the Economic Census in Egypt by law .

5 - Coverage :

The Economic Census in Egypt covers all the Economic activities , all establishments belonging to all sectors (Through Full Enumeration) .

6 Content :

Economic Censuses Provide us with detailed information on the following :

- Number of the economic establishments .
- Number of workers and their wages .
- Value of production on and requirements for producing the production or the services .
- Fixed assets.....etc .

This information are to be obtained at the regional (Governorates)

as well as national level .

7 - Prequancy :

CAPMAS carried out three Economic Censuses in 1991/ 92 , 1996 / 97 and 2000 / 2001 .

8 - Methods :

Economic Census in Egypt depends on the (General Census) which provides us with the frame of establishments .

9 - Data Products :

Data products depend on the content of Economic Census which had mentioned on point 6 .

The contents of Economic Data are very important for planners , researchers . policy makers and international organizations .
