#### Part I: General comments

In the space below, please provide any general comments, such as about the clarity with which the new recommendations were incorporated. Also, you may wish to comment on whether there is enough cross-referencing to earlier chapters for the basic concepts and definitions used in the supply and use tables (30 words or less).

#### Comment:

First I regret that this comment is late compared to the deadline. The delay is mainly due to this very busy time of the year, but also because we found that quite a few things in the draft chapter needed more time for discussion that we had originally expected.

In general we have the following positive observations:

- The partition of the present SNA chapter 15 into two chapters is a good idea
- The supply-use system as central in the compilation of national accounts data having been moved forward in the chapter
- The new section on the final use matrix
- The omission of the cross classification with institutional sectors

However, we do also have severe concerns with the current draft. A few general points are:

- In section A we find it very artificial to distinguish between "Commodity balances" and "Supply and Use tables". To us this is the same.
- Why is the term old 1968 SNA term "commodity" used? In the rest of the updated SNA the term "products" is used (as in the 1993 SNA). It should only appear as part of the term "commodity-flow-method".
- The introduction of the term "producing units" is confusing. Sometimes it is used as meaning establishment, sometimes in the meaning of industries. In general it

should be replaced by the proper SNA term "industries"

- The balance between the description of trade margins on the one hand and transport margins on the other doesn't at all reflect the importance and the complexity. We propose to cut down the description of the transport margins and enlarge the description of the trade margins. Thus, apart from the new par. 15.63 on goods sent abroad for processing the present SNA par. 15.40-44 may be reinstated.
- The description of the cif/fob adjustment is confusing. It can only be understood if you as a starting point have an inconsistent system where the import of goods are valued at cif and at the same time the imports of services are valued at a level which assumes that the import of goods are valued fob. At least these assumptions should be made clear. (We are aware that this problem is already in the present 1993 SNA text).
- The supply table in volume terms seems almost to disappear. The deflation of imports is mentioned in 15.126 and the deflation of output is very shortly mentioned in 15.130. In both cases it is in the section called "Expressing the *Use* table in volume terms".

In general we agree with the comprehensive comments made several others, especially by the Netherlands, the UNSD and Eurostat, but will in addition to the above in a few days send the draft chapter text with a number of more concrete proposals indicated by track changes.

#### Goods and services account

As the foundation of the supply and use tables, the goods and services account is discussed in paragraphs 15.7. This account also serves as a preliminary step to the material on the summary measures of the accounts (now in chapter 14, but to be moved in the next version of the full set of chapters where this chapter on the goods and services account and supply and use table will be chapter 14, prices and volumes will be chapter 15 and part of the existing chapter 14 will be described as "Summarising and integrating the accounts" in place of the present title of "Summarising and presenting the accounts" and will be chapter 16.).

The decision on how to record goods for processing has implications for how to record transport margins on such goods. Further, the principles of how to record trade and transports margins within supply and use tables when valuation is at basic prices as compared with purchaser's prices were not elaborated in the *1993 SNA* text. Such a clarification is now provided (paragraphs 15.42-15.66)
