21.9	Replace 'increases correspondingly' with 'reflects this'. (Equity values may go down as well as up). Incidentally the rest of the paragraph could be redrafted/simplified.
21.11	We may need to be careful here. 'Bankruptcy' is a loaded word and it's not clear to me that we can state with certainty in the SNA the processes that occur after bankruptcy. The text certainly reflects the man on the Clapham Omnibus's perception of things but I'm not sure it reflects the legal definition of the word and subsequent processes in every country. Chapter 11 bankruptcy in the US for example doesn't seem to apply although Chapter 7 bankruptcy does,
21.12	The sentence: "If the company is one that had issued shares, it can only be wound up if all shareholders agree or if all the shares are first acquired by a sufficiently small number of units who can reach agreement to wind up the corporation" seems to be saying that as long as legal conditions are satisfied concerning shareholder votes, a company can be wound up. Why the torturous text?? Replace company with corporation.
