	household'. This particular sentence needs clarification. Because, in the Indian
	context, domestic servants could be employed in two ways – i) Domestic
	servants employed on part-time basis visits a particular household(s) during a
	particular time and performs the work assigned to him/her viz. cleaning of
	house, utensils, washing of clothes, baby-sitting etc. and at the end of the day
	he/she goes back to the household to which he/she actually belongs. On a
	particular day services are provided by domestic staff in more than one
	household. We can treat this particular category certainly as members of
	another household. ii) Domestic servants employed on full-time basis stays
	permanently with the household employs him/her and visit his/her family once
	in six months / a year. This is very much prevalent in many parts of India. For
	all practical purposes (Census, socio-economic surveys conducted by National
	Sample Survey Organisation), he/she is treated as a member of the household
	employs him. Therefore, individuals providing paid domestic services need
	not be members of another household following the above concept. Here,

the definition of household generally followed in surveys differs from the intention of household concept in this draft chapter. 'Payments to children for performing tasks in the house are not treated as the provision of paid domestic services but simply a transfer within the household.' There are two issues: i) Payments to any member of the household by head of the household be treated as transfers within the household (why only children?) ii) Whether it shall be treated as transfer at all? Because, 'A transfer is defined as a transaction in which one institutional unit provides a good, service or asset to another unit without receiving from the latter any good, service or asset in return as counterpart' (8.27 of SNA 1993). Further, in the case of current transfers 'they directly affect the level of disposable income and should influence the consumption of goods and services' (8.32 of SNA 1993). However, this particular transfer to children is not affecting the level of disposable income, but it may influence the consumption of goods and services, as the children / or any member of the household likely to spend the same. Therefore, strictly following the present concept of transfers payments to children should not be treated as transfers and clarification is required, unless the intention in the draft Chapter is to merely distinguish between payments for services and transfers within the household.
