General comment	The title of the chapter "Informal aspects of the economy" looks odd especially when it is not clearly defined as to what the "informal aspects" of the economy are.
	Along with the discussion on informal sector the chapter includes discussion on other production concepts like illegal production, underground production, non-observed production, giving an impression as though these are necessarily parts of informal sector. With inclusion of these, the emphasis of the chapter on informal sector appears to have been diluted specially when these topics have already been discussed elsewhere, for example, illegal and underground production in chapter 6 and "non-observed economy" in Chapters 6, and 19.
