Comment:

Moving the paragraphs concerning the ancillary activities to where they are now generates some lack of clarity, because they are needed in Part C.

We couldn't find an explicit definition of ancillary establishment (AEG Rec. 25a).

We suggest to use the definition of local KAU in ESA 1995 2.106 in order to clarify / define the establishment in the draft SNA. This relates to the clarification point 21.

The description of the analytical unit as result of manipulation of statistical data is confusing; an analytical unit is a concept for which data are produced by means of calculations for the whole set of units of homogeneous production (not for the individual analytical unit). The original 5.45 should be re-introduced.

There are two paragraphs with the number 5.28 (after 5.19 and after 5.27).

1. Section D, paragraphs 5.37 - 5.40:

The treatment of ancillary activities has changed in the 1993 SNA Rev.1. The new treatment is described in paragraphs 5.37 – 5.40. Please indicate whether the description is sufficiently clear and comprehensive.
