In your review of this Add.1, you may wish to devote particular attention to the passages listed below. For ease of reference, we have identified the relevant paragraphs. 1. In order to clarify the limits of social benefits, paragraphs 8.79-8.82 of the revised text shown in Add.1 describe receivables by households from government, NPISHs and other units that are **not** social benefits. Do you find it helpful to clarify that such items are not treated as social benefits? Are the distinctions clear and sufficiently complete?

8.78	In the first sentence insert 'cash or in kind' after current transfers.
8.78	The second sentence is not clear
8.78 Sentence 3	It will be appropriate to reinstate paragraphs 8.60-8.61 from the draft chapter 8 dated 8/1/07 as they provides an elaboration on the word 'circumstances' appearing in the definition of social benefits (new Paragraph 8.78 sentence 1)The new paragraphs 8.79-8.82 do not as well make for clarity.

2. Paragraphs 8.83-8.91 of the revised text shown in Add.1 set out the distinction between social security and social assistance. Institutional arrangements for the ways that government provides social benefits vary widely from country to country so that distinctions that hold generally are difficult to draw. Are these guidelines set out in these paragraphs clear? Can you think of any other way that is internationally robust to reinforce the distinction between social security and social assistance?

8.83 Line7	Line 7 distinguishes the schemes under which social benefits are payable. Definitions of these schemes appear in Paragraphs 8.82-8.85 of the draft chapter dated 8/1/07. For clarity, insert the paragraph 8.82 before the present paragraph 8.84 and the paragraphs 8.83-8.85 after the present paragraph 8.86

3. Section H of the revised text shown in Add.1 discusses the redistribution of income in kind account and its relation to the concept of actual consumption. Discussion of this
