Subprogramme 1: National accounts, income distribution and related statistics

The objective is to develop further and implement the system of national accounts and balances and related systems and classifications and to provide a framework for the integration of economic and social data and more comprehensive and reliable statistics on national accounts and balances and related areas, such as the distribution of income and consumption, with special emphasis on the needs of developing countries.

Subprogramme 7: Support of technical co-operation

The objective is to assist developing countries through the relevant outputs described in subprogrammes 1 to 6 and, through advisory and technical co-operation activities, to develop further their statistical capability and the required statistics for monitoring and directing their economic and social development.
