- I. PROPOSED WORK PROGRAMME OF THE STATISTICAL OFFICE FOR 1984-1985 $\underline{1}/$
- 1. The following is a tentative work programme which has not yet been reviewed by the Programme Planning and Budgeting Board and is subject to change in the light of the Board's review of the relevant submissions for the proposed programme budget for the biennium 1984-1985 and of the Secretary-General's decisions on the proposed programme budget as a whole to be submitted to the General Assembly for consideration and approval.

Subprogramme 1: Development of concepts and methods

The objective is to develop further and to improve economic, social, demographic and environment statistics at the national and international levels, in terms of their timeliness, quality, scope and coverage, usefulness, comparability and accessibility.

Subprogramme 2: Application of advanced technology in the collection, processing and dissemination of statistics

The objectives are: (a) to disseminate statistics at the international level through the issuance of recurrent general compendiums of economic and social statistics, (b) to apply more efficient and effective means of managing a statistical integrated data base, providing direct access to an information network for the provision of data, the more efficient production and storage of statistics and the improved dissemination of all outputs, including responses to ad hoc inquiries.

The objective is to collect, compile, evaluate and disseminate comprehensive, reliable, useful and timely social, demographic and environment statistics that are as comparable as possible in order to serve the needs of national and international users.

The objective is to promote co-ordination of the international statistical system, including technical co-operation activities, and to provide statistical services to intergovernmental bodies, units within the Secretariat and other United Nations bodies; the Statistical Office serves as a focal point for the international statistical system.

Subprogramme 8: Programme support

8.1 Programme formulation and management

- (a) Direction and management of the Statistical Office;
- (b) Preparation of medium-term plans, budgets, performance reports and publication programmes;
- (c) Development of a management information system for control of project development and efficient utilization of staff resources;
 - (d) Maintenance of a correspondence registry;
- (e) Liaison with other offices and departments; awareness of decisions of intergovernmental bodies which may have significance for statistics; and
- (f) Maintenance of relationships with the senior staff of national statistical offices and international organizations.

Subprogramme 9: Support of technical co-operation 3/

The objective is to assist countries in developing their statistical capabilities, including the application of modern computer technology for processing statistical data, through direct advisory services, fellowships, provision of supplies and equipment, issuance of methodological material and through substantive support and monitoring of technical co-operation projects.

- 2. The proposals of the Statistical Office on priorities for programme elements for 1984-1985 are as follows:

- 1.4 Development of concepts, classifications and methods for international trade, transport and related statistics
- 1.7 Development of concepts and methods for the integration and linkage of social and related statistics and indicators
- 3.1 Collection, compilation and dissemination of national accounts statistics
- 3.2 Collection, compilation and dissemination of statistics on the distribution of income, consumption and accumulation
- 3.3 Collection, compilation and dissemination of industrial, construction and distributive-trade statistics
- 3.4 Collection, compilation, dissemination and analysis of international trade statistics
- 3. The proposals reflect as far as possible the views expressed by the Statistical Commission at its twenty-first session. 4/ The assigning of the "lowest priority" and "containing some outputs and/or activities of lowest priority" labels to programme elements was especially problematic. Some of the work under programme elements 1.4, 7.2 and 7.3 (except for that on the Standard International Trade Classification (SITC), Rev. 3) is judged to be such that it can be postponed for a biennium, if necessary. Activities and some outputs or parts of outputs under programme elements 3.1 to 3.4, which cover collection, compilation and dissemination in various fields of statistics, could be modified, if necessary. Also, this work could be studied to see whether it might be carried out more efficiently with appropriate technology so as to release resources for other activities. Such a possibility was recognized by the Commission at its twenty-first session. 5/

III. DEPENDENCIES AMONG PROGRAMME ELEMENTS IN THE WORK PROGRAMME, 1984-1985

- 4. The dependencies which will be the most immediate and direct during the 1984-1985 period, based on work scheduled for that period, are:
- (a) Dependence of the data collection programme elements (3.1 to 6.3) on the improved computerization of statistics programme element (2.2);
- (b) Dependence of the programme element "General compendiums of economic and social statistics" (2.1) on the data collection programme elements (3.1 to 6.3);
- (c) Dependence of the programme element "Provision of statistical services to General Assembly organs and other bodies, on request" (7.4) on the data collection programme elements (3.1 to 6.3) and the programme element on improved computerization of statistics (2.2).
- 5. Dependencies which are of a more long-term nature are:
- (a) The data collection programme elements (3.1 to 6.3) are dependent upon the methodological development programme elements (1.1 to 1.9) in the long run. Developments under the data collection programme elements also affect the methodological development programme elements in the long run;
- (b) The programme element on improvement of statistical capabilities of developing countries (9.1) is dependent upon the methodological development programme elements (1.1 to 1.9). Developments in programme element 9.1 also affect the programme elements on methodological development and data collection, compilation and dissemination,
- (c) The programme element on improvement of statistical data-processing capabilities of developing countries (9.2) also affects the data collection, compilation and dissemination programme elements.
- 6. In addition, there are numerous other relationships and links between programme elements. For example, there are links among the various programme elements in statistical methodology, among the programme elements concerning energy and industrial statistics and among those concerning environment and demographic and social statistics. The nature and intensity of those links change over time as the specific activities and outputs covered by the programme elements change.
- 7. Virtually all programme elements depend on the programme elements on co-ordination of the statistical programme of the United Nations (7.1) and programme formulation and management (8.1) on a continuing basis.

IV. COMMITMENTS MADE BY THE STATISTICAL OFFICE IN RELATION TO THE WORK PROGRAMME FOR 1984-1985

8. The listing which follows relates to special commitments made for work during 1984-1985 over and above the normal ongoing commitments of the Statistical Office to produce international statistics in its recurrent statistical publications, to produce publications on statistical methodology, to carry out its co-ordination function to provide support for technical co-operation in statistics and to provide statistical services to General Assembly organs and other bodies, on request.

1.1 Development of the United Nations System of National Accounts (SNA) and linkage with the System of Balances of the National Economy (MPS)

To participate in an Intersecretariat Working Group on National Accounts for co-ordination of work plans for the revision of SNA with OECD and EUROSTAT; co-operate with ECE and CMEA on work on linkages between SNA and MPS.

To provide descriptions of national practices in input-output tables for a UNIDO publication.

1.2 Development, updating and harmonization of standard international classifications

To work towards harmonization of international economic classifications including continued participation in the Joint United Nations Statistical Office/Statistical Office of the European Communities Working Group on World-Level Classifications; to continue participation in the work of the Harmonized System Committee of the Customs Co-operation Council; to work towards revision of the International Standard Industrial Classification (ISIC) and development of a combined production/goods classification and associated classifications of non-transportable goods and services linked to the revised ISIC; to continue participation in the Maintenance Agency for International Standard (ISO 3166) (codes for the representation of names of countries) of the International Organization for Standardization.

1.4 Development of concepts, classifications and methods for international trade, transport and related statistics

To issue the Standard International Trade Classification (SITC), Revision 3, by the time that the revision of the Customs Co-operation Council Nomenclature (CCCN) and the Harmonized Commodity Description and Coding System (HS) come into force (scheduled for January 1985).

Commitment, as set out in the project document on the development of shipping statistics, to compile statistics on the flow of goods on world sea lanes and to promote the uniform system for the development of economic statistics of shipping.

1.5 Development of concepts and methods for statistics of prices and purchasing power comparisons

To work with ILO to complete the Manual on Consumer Price Indexes in 1985.

To work with EUROSTAT, OECD and ECE on international comparisons and to play a strong co-ordinating role in work on international comparisons.

1.6 Development of concepts, classifications and methods for demographic, housing and human settlements statistics

To review census recommendations, taking into account the ILO International Conference of Labour Statisticians, 1982.

1.7 Development of concepts and methods for the integration and linkage of social and related statistics and indicators

To prepare a progress report on the improvement of statistics and indicators of the situation of women for the World Conference to Review and Appraise the Achievements of the United Nations Decade for Women.

1.8 Development and use of statistics for services to children and youth

Commitment to UNICEF to support and encourage the development of social statistics, especially statistics useful for services to children and youth in developing countries.

1.9 Development of concepts, classifications and methods for environment statistics

To undertake activities leading to the provision to UNEP of outputs specified in the project document on environment statistics.

2.2 Improved computerization of statistics

To work with the regional commissions and the specialized agencies and other international organizations in a technical working group on statistical data bases.

3.1 Collection, compilation and dissemination of national accounts statistics

To process input-output statistics, to maintain a data bank for UNIDO and other users and to publish the <u>Compendium of Input-Output Tables</u> as part of the National Accounts Series. Agreement with OECD and EUROSTAT on sharing work for national accounts collection and processing and with IMF on government sector accounts and tables and external transactions.

3.3 Collection, compilation and dissemination of industrial, construction and distributive trade-statistics

To provide industrial statistics to UNIDO, especially for developing countries; to provide indexes of industrial production and employment to the regional commissions.

3.4 Collection, compilation, dissemination and analysis of international trade statistics

To continue to provide trade statistics to international organizations, especially UNCTAD, for ongoing analytical work.

3.5 Collection, compilation and dissemination of transport statistics

See description under programme element 1.4 above.

6.1 Collection, compilation and dissemination of demographic statistics

To prepare a special statistical report for the International Conference on Population, 1984.

6.2 Collection, compilation and dissemination of social and housing statistics

Commitment to the United Nations Centre for Human Settlements (Habitat) to produce the Compendium of Human Settlements Statistics. Commitment to producers and users of social statistics to work on the Compendium of Social Statistics. To prepare special data for international conferences or years in specialized fields of social concern, for example, youth, the disabled, crime and criminal justice.

6.3 Collection, compilation and dissemination of environment statistics

See description under programme element 1.9 above.

7.1 Co-ordination of the statistics programme of the United Nations

To service the Statistical Commission, its Working Group on International Statistical Programmes and Co-ordination, the Committee on Contributions and the ACC Sub-Committee on Statistical Activities.

9.1 Improvement of statistical capabilities of developing countries

To provide support, on request.

9.2 Improvement of statistical data-processing capabilities of developing countries

To provide support, on request.

V. MOBILITY OF HUMAN RESOURCES, 1984-1985

- 9. The staff of the Statistical Office tend to have been recruited as specialists in particular fields or to have progressed through the ranks in the Office but normally in the same general area of work. Technical knowledge beyond their present fields of work would normally have been obtained several years previously. Opportunities to alter the skill composition of the staff and their deployment among various tasks are limited and are determined largely by resignations, retirements and transfers.
- 10. The Office undertakes advanced work on new developments in methodology in various fields, requiring a high level of expertise. The requirement would normally not be met by staff employed in other fields or activities in the Statistical Office.
- ll. There is greater mobility of staff between some programme elements than between others. There is relatively high mobility among programme elements in the same subject-matter, that is, between methodology and data collection and technical co-operation in a given subject-matter. The reverse movement, that is, from data collection to methodology in the same subject area, is less in some cases. There is moderate mobility from a programme element covering data collection in one field of statistics to a programme element covering data collection in another field. There is low mobility from a programme element covering methodology in one field of statistics to a programme element covering methodology in another field except when the fields are closely related. Some programme elements have a range of related activities, so there can be mobility of staff within a particular programme element.
- 12. A number of staff redeployments have been initiated over the past several years. In addition, a number of measures have been taken to promote greater mobility of staff, including the organization of a series of staff seminars on a wide range of activities of the Office and a series of general staff meetings at which the activities of each organizational unit were explained and discussed.
 - VI. STEPS IN THE REVIEW PROCESS FOR THE WORK PROGRAMME FOR 1982-1983
- 13. Preparation of the 1982-1983 programme budget in statistics commenced with the issuance of instructions by the Assistant Secretary-General for Financial Services, on 19 August 1980.
- 14. The instructions set forth the following steps for formulating and reviewing the programme budget:

(c) Review of submissions by the Budget Division and, in the economic and social sectors, by the Office for Programme Planning and Co-ordination; completion of the budget text and submission for translation and reproduction

1 November 1980-15 March 1981

(d) Budget text available in all languages to the Committee for Programme and Co-ordination and the Advisory Committee on Administrative and Budgetary Questions

30 April 1981

- 15. The Statistical Office prepared its draft work programme and budget proposals, which were discussed within the Department of International Economic and Social Affairs, including with the Office for Programme Planning and Co-ordination, and with the Budget Division. That proposed draft was submitted to the Statistical Commission at its twenty-first session ("Proposed draft work programme of the Statistical Office of the United Nations, 1982-1983" (E/CN.3/XXI/CRP.1)). 6/Subsequently, the proposed draft was amended to take into account the comments and decisions made by the Commission during the session as a whole and, in particular, during the discussion of the proposed draft. 4/
- 16. In the two-three months immediately following the session of the Statistical Commission, the Office for Programme Planning and Co-ordination and the Budget Division, in consultation with the Office of the Under-Secretary-General of the Department of International Economic and Social Affairs and the Statistical Office, made further changes. The revised proposals were issued as Proposed programme budget for the biennium 1982-1983, section 6, Department of International Economic and Social Affairs. 7/ A/36/6, vd IA6.53-666.
- 17. The changes in the proposed programme budget in statistics were accounted for by: (a) decisions of the Statistical Commission at its twenty-first session; (b) limitations on the printing budget; (c) limitations on the consultancy budget; (d) carry-overs from the approved 1980-1981 work programme; (e) re-evaluations of resource requirements and availability and/or co-ordination with related work in other organizations; (f) deletions owing to completions during the 1980-1981 biennium. The detailed list of changes is contained in chapter VII below.
- 18. Highest and lowest priority designations in the proposed programme budget were assigned to selected programme elements in consultation with the Under-Secretary-General of the Department of International Economic and Social Affairs and the Director-General for Development and International Economic Co-operation, reflecting as far as possible the comments of the Statistical Commission at its twenty-first session.
- 19. The proposed programme budget was reviewed by the Committee for Programme and Co-ordination at its twenty-first session, held in New York from 4-29 May and on 8 and 9 June 1981. "The Committee was satisfied, in general, with the proposed programme budget of the Statistical Office". 8/ It recommended that:

- "(a) The Economic and Social Council should request the Statistical Commission to review and evaluate the general policy of publication of statistics which are more than three years old;
- "(b) The programme should accurately reflect decisions of the Council on the question of technical assistance to developing countries for the development of energy statistics". 9/
- 20. The proposed programme budget was reviewed by the Advisory Committee on Administrative and Budgetary Questions during its meetings between 28 April and 10 July 1981 in New York. The Advisory Committee concluded that

A/36/7

- "As regards the request in paragraph 6.58 of the proposed programme budget for a new P-5 post for the Chief of the Social and Housing Statistics Section, the Advisory Committee notes that there are already 12 regular-budget posts at the P-5 level in the Statistical Office. In the Committee's opinion there should be room for the redeployment of one of those posts to the Social and Housing Statistics Section. Accordingly, the Committee recommends that the new P-5 post should not be approved, with a consequential reduction of the estimate for section 6 by \$67,600." 10/
- 21. The proposed programme budget and the views of the Committee for Programme and Co-ordination thereon were considered by the Economic and Social Council at its second regular session of 1981, held at Geneva from 1 to 24 July 1981. The Council decided to endorse the conclusions and recommendations of the Committee for Programme and Co-ordination and to transmit the report to the General Assembly for consideration at its thirty-sixth session (Council decision 1981/180 of 23 July 1981).
- 22. The Fifth Committee of the General Assembly considered the proposed programme budget and the recommendations of the Committee for Programme and Co-ordination and approved the establishment of the P-5 post as requested in the proposals (see A/36/845, paras. 15-16).
- 23. By resolution 36/240 of 18 December 1981, the General Assembly approved the programme budget for the biennium 1982-1983, as recommended by the Fifth Committee.
 - VII. CHANGES MADE IN THE 1982-1983 WORK PROGRAMME AS A RESULT OF THE REVIEW PROCESS FOLLOWING THE TWENTY-FIRST SESSION OF THE STATISTICAL COMMISSION

 - A = The output is complete and the manuscript has been submitted for final editing, translation and printing.
 - B = A final draft has been completed, incorporating the views of experts, etc. Some refinements need to be incorporated and a final review needs to be undertaken.
 - C = A first draft has been completed and is ready for review by experts, regional commissions, specialized agencies. It is expected that significant revision may be required.
 - D = A substantial amount of the basic research has been completed and an outline has been prepared.
 - E = Work has not started.
- 26. The approximate stage reached for the recurrent data publications are denoted as follows:

- A = All tables and technical notes are complete and ready for printing.
- B = All tables are substantially complete, subject to final review, correction etc.; some final data may need to be added.
- C = The data are coded and in machine-readable form, and technical notes have been prepared; some tables may also have been prepared.
- D = A significant amount of data has been received and initial checking has been completed.
- E = Work has not started.
- 27. For both kinds of publications, the stages correspond roughly to completion percentages as follows:
 - A = 100 per cent
 - B = 75 per cent
 - C = 50 per cent
 - D = 25 per cent
 - E = 0 per cent
