A. Introduction

1. The proposed programme of work presented in this conference room paper has been prepared by the Director of the Statistical Division of the United Nations Secretariat (UNSTAT). The Statistical Commission may wish to review the proposed programme of work and provide its comments to the Secretary-General, bearing in mind that he cannot commit himself to the adoption of such suggestions or recommendations before the completion of the proposed programme budget for 1994-1995, which is to be submitted to the General Assembly at its forty-eighth session for consideration and approval.

2. Moreover, in preparing these tentative proposals for the general orientation of the statistics programme for the biennium 1994-1995 two special factors have had to be taken into account. The first is the ongoing process of restructuring the economic and social sectors of the United Nations Secretariat, including the establishment of the new Department of Economic and Social Information and Policy Analysis (DESIPA). UNSTAT is expected to be part of this new Department. While the decision to establish DESIPA has already been taken by the Secretary-General, the final decision on the 1993 resource base of the Department, including UNSTAT, will not be known until the General Assembly at its resumed forty-seventh session takes its decision on revised budget estimates for the 1992-1993 programme budget. Moreover, because DESIPA has not yet begun functioning as a Departmental entity it is not yet possible to ensure that Departmental priorities are fully reflected in the proposed work programme for UNSTAT for 1994-1995.

3. The second special factor is the need to respond to the requests of the Statistical Commission at its twenty-sixth session that a more transparent method be developed for presenting the proposed work programme and the decisions of the Working Group on International Statistical Programmes and Coordination at its fifteenth session, particularly decision number 2 (E/CN.3/1993/21), requesting the Director of UNSTAT to prepare several options for consideration by the Commission as to how UNSTAT might best redeploy available resources to meet new priorities and challenges. The implementation of these requests and decisions are reflected in several ways: first, in the new format of the proposed work programme; second, in the content of the proposed work programme itself; and third, in the discussion of further possible options for modifying the proposed work programme.

B. Format of proposed work programme

4. In response to the request of the Statistical Commission and its Working Group for a simplified way of presenting information on its proposed programme of work, a major change in the format has been introduced. The new format was developed with four features in mind: first, it is organized by subprogramme within substantive and functional areas of statistics. These substantive and functional areas are identical to those used in documents E/CN.3/1993/22 and E/CN.3/1993/23, also before the Commission. Paragraphs 4 to 6 of the first document describe the origin of the classification of substantive and functional areas used and the decisions made in the implementation of this classification. The categories of the classification used in this conference room paper are limited to those activities in which UNSTAT is active. The five subprogrammes of the statistics programme are: 1. Developing statistical concepts and methods for use by Member States; 2. Applying advanced technology in collecting, processing and disseminating integrated statistics; 3. Collecting, compiling and disseminating international statistics; 4. Coordinating international statistical programmes; and 5. Support for technical cooperation in statistics and statistical data processing.

5. Second, the information presented is as specific and clear as possible to describe the proposed work to be done and outputs to be produced using language that is specifically addressed to the members of the Statistical Commission. The final proposed programme budget for the biennium 1994-1995 will be prepared in accordance with the pertinent United Nations rules, regulations and instructions.

6. Third, the proposed work programme is listed in terms of individual outputs, activities or services, including in some cases intermediary outputs, activities or services. The decision to include references to such intermediary work was again made in the interest of transparency. The goal is to present, in summary form, what UNSTAT staff are expected to work on in the 1994-1995 biennium. Formal programme budget submissions are focused on final outputs.

7. Finally, the new format allows for at least limited information on the source of funding to be presented. Accordingly, any output that will be produced substantially on the basis of resources external to the regular budget of the United Nations is indicated by an "XB" for extrabudgetary.

C. Other developments affecting the proposed programme of work

The Statistical Commission's Working Group on International Statistical 8. Programmes and Coordination established a series of ad hoc task forces to address improved burden sharing and coordination in six fields of statistics (E/CN.3/1993/21, annex II, decision 5). Although the task forces themselves are, for the most part, only at the early stages of their work, the concerns expressed by the Working Group have already initiated a process which can reasonably be expected to make the global statistical system more effective as well as result in savings that can be used by each organization, including UNSTAT, to carry out other important activities. For example, cooperation between EUROSTAT and UNSTAT in the field of international trade statistics is expected to improve the consistency of data as between the two organizations and make available resources in UNSTAT so that UNSTAT will be better able to continue its work on the improvement of COMTRADE as a basic source of data on international commodity trade. The same spirit of expected collaboration is incorporated in the proposals for ad hoc expert group meetings where it is assumed that several of such expert group meetings will be jointly organized and financed with one or more other agencies.

9. As part of an internal review within UNSTAT, the statistical publications in each individual subject-matter areas were re-examined in terms of continued relevance and usefulness. (The general statistical publications, i.e. the <u>Statistical Yearbook</u> and the <u>Monthly Bulletin of Statistics</u>, were the subject of a special ad hoc expert group meeting held from 1 to 5 February 1993). The review focused on two issues: (a) was there a substantial justification for more than one recurrent statistical publication by UNSTAT in each subject-matter field and (b) how could the quality, timeliness of publications and other statistical outputs be improved. Most of the results of this examination are discussed in section E of this conference room paper below in

terms of options and recommendations. However, two specific results of this review are already reflected in the proposed work programme for 1994-1995. First, the second recurrent statistical publication in national accounts, <u>National Accounts Statistics: Analysis of Main Aggregates</u> hitherto published annually is omitted from the 1994-1995 proposed work programme. It is proposed that any special analytical studies in national accounts that may be carried out in the future will be done as part of the overall departmental efforts. If separately identifiable outputs occur, they will be programmed individually. Second, a major obstacle to developing simpler and more responsive statistical products is the software programmes now used in the compilation and production of existing statistical publications in national accounts, trade and industrial statistics. Accordingly, an initiative to obtain needed consultancy services to provide the needed software is proposed in annex III.

10. A number of Secretariat-wide and department-wide initiatives are also expected to have a substantial impact on the UNSTAT work programme in 1994-1995. These include: the modernization of management and administrative policies, structures and procedures and the further development of computing and telecommunications systems, methods and processes. It is also anticipated that UNSTAT will make major contributions to these initiatives within DESIPA. The impact of these expected initiatives are only partially reflected in the proposed programme of work.

D. Proposed programme of work in statistics for 1994-1995

11. Subject to the qualifications set forth in document E/CN.3/1993/25 as well as the qualifications set forth above, the proposed programme of work is set out in annex I, arranged by substantive and functional activities and subprogrammes. More information on the proposed ad hoc expert group meetings and consultancies are given in annexes II and III, respectively. In considering these proposals the Commission may also wish to consider possible options for further modification discussed in section E.

In terms of broad areas of work in UNSTAT, it is proposed that special 12. emphasis in the 1994-1995 biennium be given to: (a) work on the coordination of the global statistical system and services to national statistical offices, including developing countries and countries with economies in transition; (b) implementation of the new System of National Accounts; (c) environment statistics, environmental indicators and environmental accounting; (d) strengthening computer processing systems and support; (e) preparations for the 1995 United Nations Conference on Women and other work related to improving gender statistics; (f) preparations for the 1995 World Social Summit; and (g) preparations and support for the 1995-2004 Population and Housing Census Decade. The proposed programme of work provides for work in these areas of emphasis, as well as for continuing work in other areas of responsibility for UNSTAT. However, additional possible options for modification are given in section E below, which could make available additional resources for this work. It is recommended that work in these eight areas be considered high-priority in the 1994-1995 biennium.

E. <u>Possible options for modifying the proposed</u> programme of work

13. A number of factors were taken into account in developing options for possible further modifications in the proposed work programme. These included: (a) assessments of the importance of outputs and services to national statistical offices, internal and external users of data and other international organizations; (b) an assessment of the size of investments already made in a specified area; (c) an assessment of the magnitude of the effort needed to continue an activity, i.e. what is saved if a given activity is cancelled; (d) the ability of certain areas to mobilize substantial extrabudgetary support; and (e) assessments of the comparative advantage of UNSTAT to carry out various activities.

14. These assessments were based on the views of members of the Statistical Commission and its Working Group expressed at recent sessions, informal consultations with producers and users of statistics in various international agencies, the regional commissions and Member States, as well as limited consultations within the Secretariat. One clear feature of this consultation process is the conflicting advice it provides. Almost everyone agrees that more and better should be done and that useless outputs should be cancelled. However, each specific proposal for change seems to be resisted by those who use UNSTAT outputs or services who say that it is something else that should be reduced or eliminated. As a result it is not possible to say that wide agreement has been achieved on the options given and even less on the recommendations made.

15. As indicated in section C above, one approach used was an examination of the justification for any second UNSTAT statistical publication in any subject-matter area. At present multiple recurrent subject-matter publications are produced in demographic statistics, energy statistics, industrial statistics, international trade statistics and national accounts. In the case of demographic statistics, the two publications the <u>Demographic Yearbook</u> and the 19-page quarterly <u>Population and Vital Statistics Report</u> serve distinct uses, are popular with paying users and the latter publication requires very little effort to produce. Accordingly, no change is recommended. In the case of energy statistics the two publications <u>Energy Statistics Yearbook</u> and the <u>Energy Balances and Electricity Profiles</u> are both popular sales publications and the latter publication is only produced every other year. A common staff produces both publications. The production of both publications benefit from close cooperative arrangements with other international organizations and users. Again, no change is recommended.

16. In the case of industrial statistics, the situation is more complex. UNSTAT is engaged in collecting, processing and disseminating two different kinds of data. The first set of data relates to the structure of industrial activity and is published annually in volume I of the <u>Industrial Statistics</u> <u>Yearbook</u> (General industrial statistics). The second set of data relates to commodity production statistics and these data are published in volume II of the <u>Industrial Statistics Yearbook</u>. Both sets of data also appear in abbreviation form in the <u>Statistical Yearbook</u> and the <u>Monthly Bulletin of</u> <u>Statistics</u>. Each set of data, general industrial and commodity production, is obtained by separate questionnaires and each is processed by a separate staff. Furthermore, while the Sales Office of the United Nations Secretariat continues to express interest in both publications, it appears that most users who telephone and write for data are primarily interested in the commodity

production statistics. Accordingly, it is recommended that the collection of general industrial statistics be suspended and that volume I of the <u>Industrial</u> <u>Statistics Yearbook</u> not be produced in the 1994-1995 biennium. This option would make available approximately two professional and three general service staff for other tasks in UNSTAT.

17. In the case of international trade statistics the two volumes of the <u>Trade</u> <u>Statistics Yearbook</u> are produced by a common staff using the same database and the same software. Once the software is redesigned (see section C above) it will be possible to produce a substantially improved publication. However, because both publications are produced and distributed as common volumes UNSTAT would achieve marginal savings if either volume were cancelled at this time. Accordingly, it is recommended that both volumes continue, pending the timely development of plans for the overhaul of this publication. On the other hand, it is recommended that, effective immediately, the collection and compilation of most quarterly trade data be stopped along with the issuance of new microfiche of quarterly trade data. As already indicated in section C, the second national accounts statistics publication has already been omitted from the proposed work programme for 1994-1995.

18. Over the years the Statistical Commission and particularly at the last session of the Commission's Working Group some members have expressed reservations about the value of the International Comparison Programme (ICP). Nevertheless, UNSTAT has overall responsibility for the global comparison, including promoting the coordination of the regional comparisons. The proposed work programme was developed on the assumption that four professional staff members would be involved in these tasks during 1994-1995. Despite the reservations expressed in the past, it is clear that UNSTAT must continue to provide some level of central support for the ICP. Such a minimum core level would be two professional and one general service staff members. If the Commission fully endorsed this option it would make available two professional staff for other tasks. However, this option, if fully implemented, would jeopardize UNSTAT's ability to provide the full range of technical support and coordination services recommended by the recent ICP expert group meeting.

19. Finally, a careful review was made of areas of statistics in which UNSTAT has only one or two professionals engaged on a full-time basis. In several such areas outstanding results have been produced, which are widely recognized in their respective fields to be of singular importance. These include, in particular, environment statistics, including environmental accounting, gender statistics and disability statistics. However, there are other specialized areas where the experience of UNSTAT has not yet been so successful. These include, for example, human settlement statistics and statistics on services. While considerable progress in these two areas could undoubtedly be made in the 1994-1995 biennium, the possibility of having a major impact in the short run appears limited, particularly given the activities and responsibilities of other organizations in these two areas. The Commission may therefore wish to consider the option of suspending activities in these two areas. This would mean that steps would have to be taken to transfer the human settlement statistics database to HABITAT or some other interested organization. It would then be possible to redeploy the one professional and one general service staff member now working on this subject to other activities. With regard to service statistics, if this option were accepted, UNSTAT would suspend work on guidelines on price and quantity statistics and similar initiatives and devote all its efforts to dissemination of information about methodological developments in this field and carrying out work on the revision of the CPC.

In both areas, if this option were accepted, UNSTAT would be available to collaborate with other organizations, but would not take any new initiative on its own. The extent of such collaboration would be dependent on the identification of any needed extrabudgetary support, whether financial or in-kind.

20. To recapitulate the options offered if fully accepted by the Commission would involve:

(a) Cancellation of volume I of the <u>Industrial Statistics Yearbook</u> and related tables in the <u>Statistical Yearbook</u> and <u>Monthly Bulletin of Statistics</u>:

Savings in the biennium: 48 professional work-months and 36 general service work-months;

(b) Reduction of work supporting ICP:

Savings: 48 professional work-months;

(C) Suspension of work on services statistics and human settlements statistics:

Savings: 48 professional work-months and 24 general service work-months.

This corresponds to six professional and four general service posts. Outputs substantially affected if these options are supported in full have been identified by an asterisk (*) in annex I.

21. To the extent that the Commission supports these or similar options, the available resources would be used as specified above and to strengthen the capacity of UNSTAT to carry out its responsibilities for coordination of the global statistical system and services to national statistical offices. However, the Commission should be aware that its discussion and its recommendations should focus on the programme of work presented in annex I. The information on staff resources shown above are indicative only. Moreover, the Commission's attention is drawn to General Assembly resolution 45/248, in which it expressed its concern at the tendency of its substantive committees and other intergovernmental bodies to involve themselves in administrative and budgetary matters.
