Thank you Mr/Madame honorable chair and distinguished delegates, Ladies and Gentlemen.

Malaysia Urban Indicators Network (MURNInet) also was developed by the Federal Department of Town and Country Planning, Peninsular Malaysia (FDTCP) to assess the performance and levels of sustainability of Malaysian cities. The status of MURNInets implementation as a check on the efforts taken by all local authorities in Malaysia toward attaining sustainable development. At the same time Malaysia fully support the creation of a group of experts for the revision of the Guidelines and Principles for the implementation of the City Prosperity Index measures.

- 4. Malaysia is also toward developing MUO-Malaysia Urban Observatory with the vision to become strong and sustainable cities through evidence-based spatial planning and policy making. Malaysia define cities based on combination of administrative demarcation, population threshold and economics activities. There are also challenges in defining the urban boundaries on the ground as urban areas was sprawl and expending over the time and demarcation of the area was also based on statistical boundaries.
- 5. Malaysia also would like to participate actively in any forums/ workshops/ relevant activities on technical and guideline on the framework of development policy regarding human settlements.
