# 51st Session of the United Nations Statistical Commission Expert Group on Refugee and IDP Statistics (EGRIS) Side event at UNSC

## Making Progress to Improve Statistics on Forced Displacement: Experiences from Developing and Implementing International Recommendations

### Short description

Reliable statistics on forced displacement are critical for informed decision-making and to ensure national policies and development plans respond to the commitments of the 2030 Agenda and do not leave these vulnerable groups behind. This need is becoming more urgent with growing numbers of refugees, asylum-seekers and IDPs globally (70.8 million), alongside the clear recognition that an adequate response requires both humanitarian and development action, as well as leadership from national authorities.

Disaggregated data by migratory status, including within the framework of the Sustainable Development Goals (SDGs), are necessary to better understand situations of forced displacement and migration more broadly, to analyse its impacts on host communities, countries and areas, to measure changes over time and to inform an adequate response. However, there are numerous challenges in producing these statistics nationally and aggregating them internationally, due to capacity constraints, varied definitions and practice, operational challenges and political sensitivities. The Expert Group on Refugee and IDP Statistics (EGRIS), established by a decision of the 47<sup>th</sup> session of the UN Statistical Commission (UNSC), has been working since its inception in 2016 to address these challenges. It is overseen by a Steering Group consisting of by Eurostat, Statistics Norway, Turkish Statistical Institute, UN Statistical Division, World Bank, UNHCR and the Joint IDP Profiling Service, and includes representatives from statistical/national authorities, regional bodies, international organisations and subject matter experts.

Bringing attention to the outputs of the <u>60+ member-strong Expert Group</u> – with a special focus on the upcoming *International Recommendations on IDP Statistics (IRIS)* and *Compilers' Manual* with technical guidance on how to implement the IRIS and IRRS (to be submitted to

the UNSC 2020 session) – this session seeks to contribute to improved availability, of statistics on internal displacement. It aims to promote nationally-owned statistics that can provide the back-bone for national development planning processes that adequately include IDPs.

Good quality statistics on internal displacement are a requirement for including these population groups in monitoring and implementing of several international agendas and agreements, including but not limited to the 2030 Agenda for Sustainable Development<sup>1</sup> and its commitment to leave no one behind, and the Sendai Framework for Disaster Risk Reduction 2015–2030<sup>2</sup>. They are also needed for monitoring progress towards the UN Secretary General's ambitious call to reduce new and protracted internal displacement by at least 50 per cent by 2030<sup>3</sup> and will also be necessary to inform action under the Global Compacts for Safe, Orderly and Regular Migration and the Global Compact Refugees<sup>4</sup> though these do not explicitly address internal displacement, as well as other relevant policy processes. In addition, the UN Secretary General has recently responded to calls from UN member states to establish a High-Level Panel on Internal Displacement that will include in its scope considerations for improving data on internal displacement.

Looking forward towards implementation, this event will showcase **examples from countries and international organizations already taking steps to put the recommendations into practice**. It will showcase examples from both refugee and IDPs contexts, with a focus on the IDP context and include a focus on different data sources as well as statistical coordination arrangements. It will also highlight the importance of **capacity development for many affected states and the critical role of peer-to-peer exchange** supported by regional institutions and international organizations in order to accelerate implementation of the IRIS and the IRRS. Building upon the momentum and progress made so far by EGRIS as well as the expertise of participants joining the UNSC, the session aims to capitalise on the "nexus" of expertise on forced displacement and statistical capacity building to identify strategic opportunities for furthering this work in the coming years.
