

19 February 2021	Submission of written statements encouraged by this date to assist the Secretariat in consolidation
Around 15 February	Onboarding of delegates into Online platform



Timeline (Commission week)

1 March, Monday	First virtual meeting of the 52 nd session of the Statistical Commission
2 March, Tuesday	Second virtual meeting of the 52 nd session of the Statistical Commission
3 March, Wednesday	Third virtual meeting of the 52 nd session of the Statistical Commission
3 March, Wednesday (early evening NY)	Draft decisions of the 52 nd session of the Statistical Commission available online
By 2PM NY (Eastern) 4 March	Member States and relevant observers submit comments against each draft <u>decision</u> item
5 March, Friday	Fourth virtual meeting of the 52 nd session of the Statistical Commission, considers the draft decisions (with all comments received) and agrees on final language for the 'informal' adoption of the report. Silence procedure then initiated.


Update on logistical arrangements

- Registration process
 - Register the composition of their delegations in the e-deleGATE portal (under ECOSOC/Statistical Commission) through your Permanent Mission.
 - Include names and emails of all members of the delegation of their Government who will attend the session
 - Essential to register through the PMs, including emails, for onboarding and access to the meeting platform

Update on logistical arrangements

- Vice-chairs will share presiding over each 2-hour session.
- Simultaneous interpretation and timing of the sessions.
- Web platform: online system will be communicated.
- Webcasting on UN WebTV.
- For each agenda item 2 min oral introduction, 3-5 statements, summary, etc.
