Background document to the report of the Inter-Secretariat Working Group on National Accounts

I. Introduction

1. The aim of this background document to the report of the Intersecretariat Working Group on National Accounts is to elaborate further on the issues that were raised in the main report. Section II of this background document presents a further update of the progress in resolving issues related to globalization; digitalization; well-being and sustainability; communication; financial and payments systems; informal economy; and Islamic finance. A summary of activities during 2021 and expected activities in 2022, related to economic statistics and national accounts carried out by the member organizations of the ISWGNA and the regional commissions, is provided in Section III. Further information on the reporting of annual national accounts data is provided in Section IV.

II. Progress in resolving issues for the updated of the 2008 SNA

Globalization

The Globalization Task Team (GZTT) has completed the drafting of all planned 2. guidance notes, seven in total. Four guidance notes related to the valuation of imports and exports; the treatment of multinational enterprises (MNEs) in the national accounts; the treatment of special purpose entities (SPEs) and residency; and factoryless goods producers and the recording of their transactions¹ have completed global consultation and testing (when requested). Three additional guidance notes are being prepared for global consultation and are scheduled to be circulated during the first quarter of 2022. These guidance notes relate to the economic ownership of intellectual property products; payments for nonproduced knowledge-based capital (marketing assets); and global value chains (GVCs) and trade in value added (TiVA). The work of the GZTT builds upon the extensive methodological work that has taken place over the last number of years. Globalization has large impacts across different areas of statistics, particularly balance of payments and international investment position statistics. Therefore, the GZTT was established as a joint task team of the ISWGNA and the IMF's Committee on Balance of Payments Statistics (BOPCOM). Therefore, the GZTT includes national accounts and balance of payments experts as well as government finance statistics experts. This crossdomain collaboration is an important aspect of the GZTT's work and will ensure conceptual and methodological consistency between the Balance of Payments Manual (BPM) and the System of National Accounts (SNA).

Digitalization

3. The Task Team on digitalization completed the work on two guidance notes, namely 'Price and volume measurement of goods and services affected by digitalization' and 'Supply and Use Tables for the digital economy', which have been endorsed by the

Advisory Expert Group (AEG) for publication. The former presents an extensive review of existing practices and provides practical guidance. The latter provides a comprehensive framework for the analysis of the digital economy. It continues to be tested in several countries and the first experimental estimates on high priority indicators have become available for a few of them.

4. The work has significantly advanced on the guidance notes on 'Clarifications of the existing SNA treatment of free products', 'Recording and valuing free products in an SNA satellite account' and 'Recording of data in the national accounts'. All pending conceptual issues have been addressed. Considering the close links between them, these guidance notes are planned to be submitted to public consultation as one package in the first quarter of 2022. Testing some of the recommendations in the course of 2022/23 will be essential to finalise them.

5. Work is advancing well on 'Cloud computing', 'Artificial intelligence' and 'Digital intermediary platforms', for which the issues to address have been identified and preliminary guidance notes have been drafted by the Task Team and discussed by the AEG. Finally, the guidance note on 'Crypto assets' has become a joint undertaking of the Digitalisation Task Team and the Task Team on Financial Issues. Guidance on the remaining open issues is being finalised and is expected to be endorsed by BOPCOM and the AEG in March 2022.

6. Cutting across nearly all these guidance notes, the need to give separate visibility to the new digital activities and products in ISIC and CPC is emerging as a crucial aspect allowing for the production of estimates in line with users' expectations. This is reflected in the importance of ensuring good alignment between the ISIC and CPC updates and the SNA update.

Well-being and sustainability

7. The Task Team on well-being and sustainability completed the drafting of four guidance notes in 2021 (on distributional results; unpaid household activities; labour, education and human capital; and valuation and depletion of natural resources), which all went out for global consultation in the second half of the year. Most recommendations received broad support, with the relevant area groups currently finalizing the notes on the basis of the feedback received. Furthermore, good progress was made on the other notes, with eight guidance notes becoming available early 2022 (amongst others on health and social conditions; emission permits; biological resources; provisions; and renewable energy resources). The note on the broader framework will then follow later on in 2022, leveraging off the various recommendations as included in the other guidance notes and summarizing how this may best be presented in conjunction and in line with the central framework, in order to provide better insights in well-being and sustainability in addition to traditional measures. In the meantime, the work and the progress made on the wellbeing and sustainability work have been presented at various occasions, including the UNECE Group of Experts, the OECD Working Parties on Financial Statistics and on National Accounts, a G20 DGI Workshop, and the International Comparison Program Technical Advisory Group. The Task Team has also begun to identify and prioritize the guidance notes (or specific parts of guidance notes) that will require experimentation and testing in 2022.

Communication

8. The SNA Communication Task Team comprises five workstreams and considerable progress has been in each workstream over the past year. The five workstreams are:

- An assessment framework to measure alignment with the economic accounting statistical standards.
- Terminology and branding of the economic accounting statistical standards.
- A taxonomy for communicating economic statistics releases, products and product updates.
- Compilers Hub.
- Digitisation of the SNA and other economic statistics standards.

9. Alongside the notable progress, presentations and feedback has been sought from different audiences such as the OECD Working Parties on National Accounts and Financial Statistics, IMF BOPCOM meetings and the AEG meetings. For the first three workstreams, separate Guidance Notes have been produced and are in the process of Global Consultation which concludes by February 2022. These Guidance Notes contain a range of proposals and questions as well as reflecting some of the comments from the above mentioned meetings.

10. With the compilers hub, progress is on schedule and the aim is to have this ready by the end of 2022.

11. With the Digitisation of the SNA and other economic statistics standards, work is progressing well and the delivery of a real-time authoring platform in time for the editorial process of the updated SNA and BPM is important.

Financial and payments systems

12. The Joint Task Team on Financial and Payments Systems is examining how to best record financial flows and positions and payment infrastructure elements in the updated SNA and BPM. Primary among its remit is to provide recommendations on how to properly record the new types of financial instruments, institutions and financial digitalization developments that have emerged since the last update of the SNA and BPM. The group is made up of a world-wide network of country and international experts across the relevant statistical domains including Monetary and Financial Statistics and Government Finance Statistics experts.

13. During 2021 the Task Team completed work on reverse transactions, financial derivatives classification, non-bank financial intermediation, valuation of loans, hybrid insurance and pension products and subscription rights. Work initiated on cash collateral and the treatment of reinvested earnings is continuing in the first quarter of 2022. Moreover, in early 2022 Global Consultations are conducted on guidance notes prepared by the Task Team on sector and financial instrument breakdowns, Fintech, Concessional debt, Factoring, margins in trading financial instruments and Crypto Assets, prior to being discussed by the AEG and BOPCOM.

Informal economy

14. The joint Informal Economy Task Team formed three sub-Task Teams on 1) to develop a conceptual framework for the Informal Economy, 2) informal productive activities facilitated by digitalization, and 3) informal cross-border flows. At the request of the AEG, the three workstreams were consolidated into one guidance note. The aim of the framework is to present recommendations for a coherent and complete presentation of the informal economy and does not focus on exhaustive measures of production. The guidance note was drafted in close collaboration with the ILO working group for the revision of the statistical standards on informality.

15. The guidance note was discussed at the October/November 2021 meetings of the AEG, BOPCOM and the ILO working group for the revision of the statistical standards on informality, as well as various regional meetings. Simultaneously, all three groups were invited to participate in an in-depth written expert group consultation which broadly supported the guidance note. The guidance note has been circulated for global consultation on 3 February 2022.

Islamic finance

16. The work of the Islamic finance Task Team (IFTT) was conducted by six "Research topic Sub-Task Teams" which were formed and assigned to the six respective topics identified in the work plan. The six sub-task teams each organized three rounds of virtual meetings from January to April 2021 in order to gain a better understanding of the nature of the Islamic finance and its standards and practices and to identify and resolve the cross-cutting issues which may sometimes be intertwined for different topics with no obvious borderline. Based on the sub-task teams' outcomes a consolidated guidance note was finalized and submitted to AEG meeting in November 2021 and BPTT for endorsement for global consultation. The consolidated guidance note was circulated for global consultation in December 2021 and ended by January 2022.

17. The IFTT in coordination with UNESCWA and UNSD organized a "Webinar on the statistical treatment of Islamic finance in the national and international accounts", supporting the global consultation on the IFTT guidance note on 16 December 2021, The webinar aims to inform compilers about the progress with the Islamic Finance guidance note under the SNA and BPM update programme, to introduce the research topics of the Islamic finance to foster informed participation in the global consultation on the Islamic Finance guidance note and to explore potential volunteers for the early implementation of the new recommendations and the experimental testing.

18. IFTT guidance note was translated into Arabic, given the relevance of Islamic finance in Arabic speaking countries and the request by ESCWA countries during the inception webinar for the Arab Region "Towards the 2025 SNA" on July 5, 2021, the need for translation into Arabic is supported by the experimental testing of IFTT recommendations that will be conducted in 2022 since a large part of the Arabic and Gulf countries are expected to take part in the experimental testing process.

III. Summary of activities during 2021 and expected activities in 2022 related to economic statistics and national accounts carried out by the member organizations of the ISWGNA and the regional commissions

Eurostat	Given the persistence of the COVID-19 pandemic, into 2021 Eurostat organised its meetings virtually. As usual, it held two meetings of the Directors of Macroeconomic Statistics (DMES), the Balance of Payments Working Group and the National Accounts Working Group. All EU, EFTA and candidate countries are represented in these groups. In addition, two meetings with the candidate countries only are held each year.
	In 2021, Eurostat organised a seminar on "Measurement of non-market output under COVID-19", to discuss country practices on the recording of collective, health and education services and possibly harmonise them. The DMES Task Force on fixed assets and estimation of consumption of fixed capital under ESA 2010 (TF FIXCAP) has drafted recommendations on the use of the PIM model to compile stocks of produced assets aiming to improve cross-country consistency. In 2022 work will continue with the aim to support countries with the introduction of improved asset estimates with the next benchmark revision in 2024. In relation to a project to publish additional labour and capital indicators, Eurostat organised several Task Force meetings and contributed presentations at related events. Following the publication of additional productivity indicators at the end of 2021, Eurostat plans to organise a seminar in 2022. A seminar and work to improve employment estimates further is also planned. There were regular meetings of the expert groups on Quarterly National Accounts, Regional accounts, Pensions, Disparities in National Accounts (with the OECD), Financial Accounts and non-financial Sector Accounts (with the European Central Bank) and GNI. The "Integrated Global Accounts Expert Group" (IGA EG), created by merging and refocusing the previous IGA Task Force and Supply-and-Use Input-Output Tables Technical Group, held its first meeting. Furthermore, in the GNI domain there were two ad-hoc meetings on globalisation-related issues and three meetings of the GNI Sub-Group on Exhaustiveness, while the ECB and Eurostat organised a second workshop to discuss the recommendations on the reconciliation of vertical discrepancies. The report on developing a common approach to improve vertical consistency is expected to be published in 2022.
	In the context of the European Master in Official Statistics (EMOS), Eurostat organised a course on Macroeconomic and Financial statistics for German universities, in cooperation with the European Central Bank and the University of Trier. The traditional training courses for European participants on national accounts and on balance of payments did not take place because of the COVID-19 pandemic.
	Eurostat continued to receive additional voluntary data from EU Member States to improve data availability under the G-20 Data Gaps agenda as well

	as for macro-economic policymaking. Eurostat and the European Statistical System (ESS) finalised the strategy to address statistical issues arising from economic globalization. This strategy, building on the accumulated experience from several ESS initiatives, aims at bringing them together into a systematic approach and at addressing issues such confidentiality, data access and communication. A first concrete step has been the creation of an ESS MNE network, which now incorporates the "Early Warning System" (EWS) to exploit the synergies. In 2021 the EWS delegates agreed on the approach for a consistent recording across countries and domains for a few restructuring cases of multinational enterprises, and anonymised notes were released on Eurostat's website. Eurostat has also significantly advanced in the process to amend the Transmission Programme of ESA 2010, i.e. the data that the EU Member States are expected to transmit to Eurostat, to better align it to evolving user needs. A proposal for the related legislative act was made by the Commission in December 2021.
IMF	The IMF's capacity development activities focus on improving the quality of national accounts in member countries. This includes implementing the latest national accounting concepts and methods, compiling quarterly accounts, sectoral accounts and developing high-frequency indicators of economic activity. In 2021, the IMF delivered 200 technical assistance projects in national
	accounts to over 96 countries and conducted over 32 national accounts courses and seminars. The IMF staffs full-time national account experts in ten Regional Technical Assistance Centers (RTACs) who provide and arrange capacity development services to over 100 member countries in Africa, the Caribbean, Central America, the Middle East, and South Asia. In 2021, the IMF opened a new Regional Capacity Development Center for the Caucasus, Central Asia and Mongolia. All of the IMF's technical assistance was provided remotely in 2021 using various digital technologies.
	In 2018, the IMF and its partners launched the Data for Decisions (D4D) Fund. The D4D Fund is expected to provide about US\$ 33 million over five years for targeted technical assistance and training. The beneficiaries are low- and lower-middle-income countries. The year 2021 marked the fourth year of work under the D4D Fund.
	Some of the D4D funding is being used to develop Online National Accounts Training programmes. During 2021, IMF staff worked with learning experts in its Institute for Capacity Development to finalize an online annual National Accounts course. Two sessions of the course were conducted with over 600 participants attending each session. The IMF Statistics Department also began the development of an online Quarterly National Accounts course in 2021. The goal is to release this course some time in 2022.

Meetings, training seminars, courses, handbooks, etc.
The D4D fund is organized around four modules, with its largest module focused on addressing data gaps and quality issues in national account, price statistics and external sector statistics, as well as on fiscal and debt reporting. The D4D Fund's founding partners comprise China, the European Commission, Luxembourg, the Netherlands, the Republic of Korea, and Switzerland.
The IMF advances its statistical agenda through the annual IMF Statistical Forum, which aims to facilitate a global dialogue on cutting edge issues in macroeconomic and financial statistics. It offers a platform to build support for statistical improvements from key stakeholders, including policymakers, data users, academics, compilers and data providers. The theme of the Ninth IMF Statistical Forum in 2021 was "Measuring the Climate Change: The Economic and Financial Dimensions".

UNSD	The activities of UNSD are focussed on operationalizing the outreach programme on the update of the 2008 SNA to: (a) inform and keep countries updated on the process of updating the 2008 SNA; (b) foster global consultation on the guidance notes; (c) collect feedback from countries and regions on their thematic priorities; and (d) explore possible volunteer countries and liaise with them for an early implementation of the new recommendations in the form of experimental estimates. For this purpose, in 2021 a series of online regional seminars were organised in collaboration with the regional commissions, AEG/ISWGNA and task teams, which first began with introductory webinars intended to inform countries about
	the overall process of updating the 2008 SNA, working methods, timelines and expected country involvement. These were followed by a number of thematic webinars to discuss more specific research topics and guidance notes.

	During the 2021 five introductory webinars were organised, two for the ECLAC region, and one each for the ECA, ECE, ESCAP and ESCWA regions (within the framework of scheduled regional activities). The seminars reached more than 800 participants from about 180 countries.
	The first round of thematic webinars will be held between November 2021 and May 2022 and will include online meetings with countries in the regions covered by the above-mentioned regional commissions. The webinars will elaborate on the priority research topics most relevant to each region and will present various guidance notes that have been completed. In addition, a topical webinar on Islamic finance was conducted for interested countries in the ECA, ESCAP and ESWA regions.
	In addition to these seminars UNSD will support countries during 2022, in collaboration with the AEG/ISWGNA, task teams and regional commissions, with developing of experimental estimates and early implementation of the recommendations of the guidance notes The aim is to involve countries from different levels of statistical development and ensure broad geographic representation.
	UNSD also developed a National Accounts Capacity Building Resources Website <u>National Accounts Capacity Development Resources</u>
	Several statistical offices and regional and international organizations develop resources for National Accounts capacity-development purposes, making them accessible on their web portals. However, due to the lack of a common entry point, these handbooks, compilation tools, courses, and training materials are available but scattered across several websites, making it difficult for compilers and users to be aware of the tools at their disposal.
	The aim with the UNSD National Accounts Capacity Building Resources Website is to provide a single-entry point to trusted resources for National Accounts capacity-development purposes. It is expected that the resources in this central repository for compilers and users of National Accounts will be expanded as new resources become available.
World Bank	The World Bank continued to provide needs-oriented technical assistance and support to countries and regional institutions to build statistical capacity, focusing on the quality and breadth of national accounts estimates, enhanced estimation methods and compliance to SNA standards. In support of these objectives, client countries in a range of countries in Western Africa benefited from streamlined processes and tools for business registers and economic surveys. Technical assistance was also undertaken via on-the-ground missions and video conferences in Dominican Republic, Yemen, Pakistan, Angola, Kazakhstan, Saudi Arabia, the Turkish Cypriot Community and Zimbabwe. Planned activities for 2022 include the continued implementation of streamlined business statistics, along with national accounts technical support

	to a range of countries including Peru, Armenia, Iraq, Somalia, and Viet Nam, where new estimates on the digital economy support the advance implementation of SNA standards.
	In support of the UN's broader outreach efforts on the SNA update, the World Bank contributed to webinars hosted for UNECA and ESCWA in the summer of 2021. The webinars served as a consultative forum for statisticians from national statistical offices and regional and international agencies to inform on progress with the SNA and BPM update programs. They also covered the inclusion of baseline assessments and the compilation of experimental estimates to be undertaken in a number of volunteering countries.
	In line with the advancement of new SNA standards for Wellbeing and Sustainability and a workshop hosted in 2020 to advance implementation of national accounts distributions for the household sector in Latin America, the World Bank continues to support this work via the next phase of the IMF-led Data Gaps Initiative (DGI). In collaboration with the OECD and the European Central Bank, input to DGI recommendations and targets was provided leading up to the global DGI conference in December 2021, while ongoing support to the initiative will be provided throughout the coming year.
	Via its ongoing work in the <i>Changing Wealth of Nations</i> program, the World Bank contributed proposed guidance on renewable energy assets for consideration in environmental-economic accounting under the Wellbeing and Sustainability Task Team. The World Bank's experience in compile cross- national measures of comprehensive wealth is expected to inform the experimentation and testing phase of the SNA update in 2022
	The World Bank launched its Global Data Facility (GDF) in 2021, a new trust fund umbrella aimed at efficiently and transparently pooling resources to support statistical development. The GDF was chosen as the funding mechanism for the SNA update, and the World Bank worked in collaboration with UNSD to support the selection by the ISWGNA of the Lead editor and Project manager for the 2008 SNA update process. Ongoing oversight of the work plan and activities of these newly hired consultants will be provided by the ISWGNA, while the World Bank and UNSD will continue to support its effective management and governance throughout the subsequent phases of the update project. Additional members of the SNA editorial team have also been identified and are expected to be onboarded by the World Bank in 2022.
ECA	Summary of activities during 2021
	<i>Price Watch Centre (PWC)</i> : ECA continued its series of regional seminars on the analysis of changes and developments of the consumer price index (CPI), as well as other price indices, with the Ministers of Economics and Finance in Africa. The PWC was initially launched in 2020 with the view to offering

	decision makers, development agencies, and the wider research community a forum to monitor the movements of prices in sectors key to development in Africa. Through discussing important economic statistics and indicators and how to apply them to policy and decision making, the seminars are expected to bring more attention to CPI and other related price statistics and improve their production and dissemination. Three seminars of this series were held in 2021 with the themes of: (i) "Importance of construction sector in the economy and prices trends in Africa" on 23 February 2021. (ii) "Energy Prices in Africa: Transition Towards Clean Energy for Africa's Industrialization" on 22 June 2021. (iii) "Commodities Prices Amid COVID-19: Prospects and Policy Implications for African Economies" on 5 October 2021.
	<i>CATI and Phone Survey for CPI Data Collection</i> : As a result of Covid-19 and related social distancing prevention measures, conducting face to face price collection surveys for CPI has become difficult if not impossible. To help Member States cope with the challenges, ECA has conducted a series of regional training webinars on the alternative approaches for CPI data collection, especially on the methods and techniques of Computer Assisted Telephone Interviewing (CATI), scanner data, and web-scrapping during the last two years. In 2021, three seminars were organized: (i) a regional e-training on the alternative techniques for CPI data collection, supported by INSEE-France, ONS-UK, Global Partnership for Sustainable Data, VIAMO, and SurveyCTO, from 25 January to 4 February 2021 - attended by more 300 people from 52 African countries, RECs, and other international and regional organizations. (ii) A virtual feasibility study session on Mobile Data Collection App (MDCA) for CPI data collection on 29 April 2021 - attended by CPI experts from countries, related international organizations, and the University of Michigan, which presented the case and initiative. (iii) a regional e-training webinar on the use of telephone surveys and CATI for CPI data collection in partnership with SurveyCTO, on 20-21 October 2021, attended by over 200 participants from 57 countries in which 50 were ECA member States. IV. Reporting on annual national accounts data

19. In accordance with the request of the Statistical Commission, the Statistics Division of the Department of Economic and Social Affairs of the United Nations regularly evaluates the availability and scope of official annual national accounts data reported by Member States and their conceptual compliance with the recommendations of the SNA.

20. The assessment presented in the present section is based on replies to the United Nations National Accounts Questionnaire for the last five reporting periods, i.e., from 2016 to 2020. The data are either reported directly to the Statistics Division or through the ECE, the OECD, or the secretariat of the Caribbean Community.

21. Considering the responses in any of the last five reporting periods (2016 to 2020), 96 per cent (185 countries) of the Member States reported national accounts data to the Statistics Division. An analysis, at the regional level shows that 100 per cent of Latin American and Caribbean countries reported national accounts data, followed by 96 per cent of African countries, 93 per cent of Asian countries, and 75 per cent of Oceanic countries.

22. In the 2020 reporting period, 170 Member States (88 per cent of the total number of Member States) reported national accounts data which is somewhat lower than in the previous reporting period. The timeliness of data is evaluated by the number of Member States that are able to submit data for the same year as the reporting period, i.e. 2020 data in the 2020 reporting period. Of all 193 Member States, 115 (60 per cent) submitted data for the year 2020 in the 2020 reporting period, compared to 106 Member States that submitted data for the year 2019 in the 2019 reporting period, and 113 Member States that submitted data for the year 2018 in the 2018 reporting period.

23. An analysis of the national accounts data shows that 188 of the 193 (97 per cent) Member States have implemented the 1993 SNA or the 2008 SNA up to the 2020 reporting period. Of those, 116 Member States have submitted national accounts data compiled according to the 2008 SNA. Specifically, 52 (96 per cent) African countries; 33 (100 per cent) Latin American and Caribbean countries; 41 (93 per cent) Asian countries; and 12 (100 per cent) Oceanic countries have implemented the 1993 SNA or the 2008 SNA. The rate of implementation by the least developed countries (LDC) and small island developing states (SIDS) have been progressing significantly, respectively with 93 per cent and 100 per cent of countries and areas having implemented the 1993 SNA or the 2008 SNA.

24. The scope of national accounts data reported to the UNSD is evaluated against a standard "minimum requirement data set" (MRDS)^{2,} adopted at the thirty-second session of the Statistical Commission in 2001, and against the "milestone"³ measure, adopted at the twenty-ninth session of the Statistical Commission in 1997.

25. A total of 139 Member States (72 per cent) provide six or more tables of the MRDS and 105 Member States (54 per cent) provide seven of the MRDS tables. Milestone 2 was observed by a majority of countries in the Caribbean and Latin America (91 per cent); Asia (86 per cent) and African (70 per cent) in the 2020 data collection cycle.

26. Although the term 'constant prices' has been replaced with the term 'volume measures', the vast majority of the Member States are still using fixed base years, hence, the reference to constant prices. Data in constant prices are not available for Eritrea, DPRK, and Liechtenstein. Over 60 Member States compile constant price data using chain linked volume measures with a fixed reference year, 17 Member States compile constant prices with the previous year's prices. There are 46 Member States that have base years older than 10 years.
