



The Sama Bajaus

- Sea-faring Indigenous Peoples group who are mostly found in Mindanao and Southeast Asia
- one of the State-identified populations at risk of statelessness in the Philippines





Birth Registration of Sama Bajau in Zamboanga City

Started in 2019

Focus Community: Vale Vista Phase 1&2 in Barangay Kasanyangan, Zamboanga

Agencies Involved:

- Department of Justice (Lead Agency in the implementation of the NAP to End Statelessness)
- The National Commission on Indigenous Peoples (NCIP) Region IX through its Zamboanga sub-office
- Local Government of Zamboanga
- UNHCR
- UNICEF
- Sama Bajau Community

Total birth certificates provided: 1,155









Challenges

The birth registration for the Sama Bajau takes time

Lack of or no documentary evidences to establish the veracity of their identity

Sama Bajaus' cultural beliefs

Delays in the process and limitations in terms of movement due to the pandemic









Strengths/Opportunities

Partners at the national, regional, local government and community levels have already established a good working relationship with each other.

Strong commitment among stakeholders involved.

Participation of the Sama Bajau community is ensured all throughout the process of implementation









Ways Forward

Continue the collaboration with partners to ensure birth registration of Sama Bajaus

Continue the leadership in the implementation of the National Action Plan to End Statelessness

Pursue parallel advocacy activities to ensure sustainability of the initiative

Expand birth registration of the Sama Bajaus in other communities in Mindanao.
