Concept note

- The sprint is jointly organized by the UN Committee of Experts on International Statistical Classifications and the Network of Economic Statisticians
- Overall objectives:
 - Raise awareness of the importance of international classifications with both internal and external users to the NSOs
 - Advance outreach by the Committee of Experts on International Statistical Classifications to engage NSOs
 - Provide an additional forum for discussing and sharing modern ways of updating and implementing classifications
 - Highlight the importance of investing in classification work as a foundation for data integration



Webinars

1st Webinar - Classifications as a foundation for data integration

The webinar will explore the role that standard statistical classifications can play for the integration of statistics across domains. It will raise awareness of the importance of international standard classifications with both internal and external users to the NSOs and highlight the importance of investing in classification work as a foundation for data integration (including data quality assurance) by showcasing real life applications inside and outside NSOs.

2nd Webinar - Mechanisms for rendering the classification process more efficient through collaboration and coordination

This webinar will provide the opportunity for the Committee of Experts on International Classifications to advance their outreach by presenting various approaches to the development and maintenance of international statistical classifications and obtaining feedback from participants. Discussion will also cover ideas for relatively more frequent revisions of standard classifications, including evergreening of the revision process to ensure that standard classifications reflect reality and support timely, relevant and sound data, for better informed decisions.



3rd Webinar -The role of technology in the classification work

The webinar will provide an additional forum for sharing Linked Open Data (LOD) approaches for updating and implementing standard classifications and discussing existing roadblocks that prevent NSOs from moving forward.

This webinar will provide the opportunity for bringing all the discussions together, as well as discuss future steps. A panel discussion is envisaged to reflect on what can be done to ensure that the role of standard classifications in the statistical systems is recognized.
