Self-assessment questionnaire on IMTS compilation practices

This questionnaire refers to the internationally endorsed recommendations of International Merchandise Trade Statistics (IMTS) contained in the IMTS 2010, Concepts and Definitions, manual (see <http://unstats.un.org/unsd/trade/methodology%20IMTS.htm>).

The purpose of the survey is to obtain an overview of the status of IMTS by comparing the existing national compilation practice against those recommendations. The questions cover the practices and circumstances in your country and are organized according to the national quality assurance framework, which was recently endorsed for use by the Statistical Commission, see <http://unstats.un.org/unsd/dnss/QualityNQAF/nqaf.aspx>.

This is a self-assessment questionnaire, since you know best the details of the compilation of trade statistics in your country. The results of the survey are useful for your office to update the meta-data, which accompany the dissemination of your trade statistics. In principle, you should list all deviations from the recommended standard in your meta-data. This information on your compilation practice is of great importance for the users of trade statistics, including the BOP compilers, trade analysts and researchers.

The questionnaire is expected to be completed by the institute responsible for the compilation and dissemination of the international merchandise trade statistics (usually the National Statistical Office) in close consultation with the Customs Administration (as the main data provider). Besides IMTS 2010, you are also advised to consult the IMTS 2010, Compilers Manual (available on the same web page) to better understand the terms used in this questionnaire.
