

Major exports: Oil and Natural Gas





December – Winter Birds






	Trinidad	Tobago
Main Types of Visitors	Business Travelers; Returning Residents; Independent Travelers (not on pre-packaged holiday).	European leisure travelers on pre-paid packaged holidays; Trinidadians.
Main Source Market	USA; Caribbean Region.	UK & Europe; Trinidad.
Accommodation Types	Some large branded hotels; Small independent hotels; Bed & Breakfast; Apartments.	Small independent hotels; Apartments & Condos; Bed& Breakfast; Villas.
Main Markets	Business Tourism.	Beaches, leisure, sun, sand and sea tourism.

Compilation of BOP Travel Account

Travel – Definition

- "Travel credits cover goods and services for own use or to give away acquired from an economy by non-residents during visits to that economy "- BPM6
 - visits of less than one year except in the case of students and medical patients.








Net Travel

- The Central Bank of Trinidad and Tobago Surveys of Universities, Government, Airlines, Shipping Agents, and Commercial Banks




Main Survey

- Central Statistical Office of Trinidad and Tobago
 - Survey on Expenditure
 - Cost of pre-paid package
 - Expenditure on accommodation, meals, entertainment, local transport (including inter-island ferry)
 - Length of stay
 - Number of persons in group
 - Type of accommodation
- Expenditure survey conducted at the two main airports (Piarco-Trinidad, ANR Robison -Tobago), approximately once every two months.




Compilation Method – Inbound

- Information on the total number of visitors to is provided by customs and immigration department, through CSO
- Use CSO data to calculate the average expenditure per day
- Use the average length of stay
- These provide information on hotel visitors, business visitors, private home and others




Compilation Method – Inbound

- Expenditure of foreign students information from the main universities in the country.
- Expenditure on advances to crew information from foreign airlines and ships



Compilation Method - Outbound

- Information from the commercial banks are used to compile statistics for tourists and other travelers, and students.
- Expenditure on advances to crew information from domestic airline.
- Costs of Official Government travel is sourced from the Comptroller of Accounts of the Central Government.





Possible Additional Sources of Information for Outbound

- Survey of the relevant government agencyfor cost of foreign scholarships
- Use of credit and debit card information
- Additional Expenditure Survey to cover arriving local passengers
- Use of arrival statistics for citizens to develop an estimate of expenditure



Possible Collaboration with Other Institutions

- Trinidad and Tobago Tourism Development Authority; Ministry of Tourism and the Central Statistical Office to develop:
 - Tourism Satellite Account
 - Model to address periodicity of information, and cyclical pattern



Other Issues

- Missing data
 - Same day visitors Cruise Ships
- Differences in Definitions
 BOP -less than one year, CSO survey less than six months



Way Forward

- Travel by Country
- Address Missing Data
- A separate breakdown of travel according to product group:
 - Goods
 - Local transport services
 - Accommodation services
 - Food serving services; and
 - Other services
